What is being proposed?

Council of The Corporation of the Town of The Blue Mountains will hold a Public Information Session and Public Meeting to provide information to the public and to allow the public the opportunity to review and comment on the proposed Affordability Policy for Municipal Water and Wastewater Service Extensions.

Information and handouts will be available, with Town representatives in attendance to respond to inquiries and to receive comments from the public.

At the September 11, 2017 Committee of the Whole Meeting staff will bring back a report with comments received from the Public Meeting and written responses. Council may consider adoption of the Policy at the September 25, 2017 Council Meeting.

Any person or agency may attend the Public Meeting and/or make verbal or written comments regarding the proposed Affordability Policy for Municipal Water and Wastewater Service Extensions.
