John Caswell reported that he spoke with some residents in Georgian View Estates in regards to the location of the holding tank and the state of the grounds around the tank. In addition, discussions were held with a local wastewater hauler who indicated there may be an infiltration problem due to the excessive amount of wastewater that has been hauled in recent months. Mr. Caswell explained to Committee that the end of cul-de-sac will be cleaned up once the frost is out of the ground, and that there did not appear to be any effluent overflowing. Staff indicated they would check the Georgian Bay Club’s water bill for the past months to compare it against the hauled wastewater.
