A. Recommendations

THAT Council receive Staff Report BL.14.29 respecting “Private MLEO Appointment Request: Blue Mountain Village Association”;

AND THAT Council direct Town Staff to proceed to review this request further and report back to Council.

B. Background

On July 22, 2014 the By-Law Services Division received a written request from the Blue Mountain Village Association (BMVA) to appoint Blue Mountain Resort Security staff as Municipal Law Enforcement Officers so as to enforce parking related Town by-laws. A copy of the written request has been attached to this Staff Report.

As the letter correctly states, Blue Mountain Resort Security Staff have been appointed as MLEOs for the purposes of enforcing By-law No. 2007-12, “Parking on Privately-Owned land Without the Consent of the Owner”. The purpose of this by-law is to regulate or prohibit parking on privately owned land unless consent of the owner is given (“parking pass”). Private MLEOs appointed under this by-law have also been appointed to issue parking infraction notices for Town By-law No. 2004-116 “Disabled Person Parking By-law” and Town By-law No. 2001-88 “Fire Routes By-law” on the privately owned lands.

To support BMVA’s request, a separate by-law is required as the lands within the Blue Mountain Village area are not a controlled parking area via parking passes but rather public access areas.

Staff believes the appointment of Blue Mountain Resort Security would be beneficial in providing additional resources to regulate parking related Town by-laws within the vicinity of the Village at Blue; however, this should be evaluated further.

Upon direction of Council to proceed with this request, Town Staff will review with the Town Solicitor and other Town Departments for comment and report back to Council along with a draft by-law where applicable.

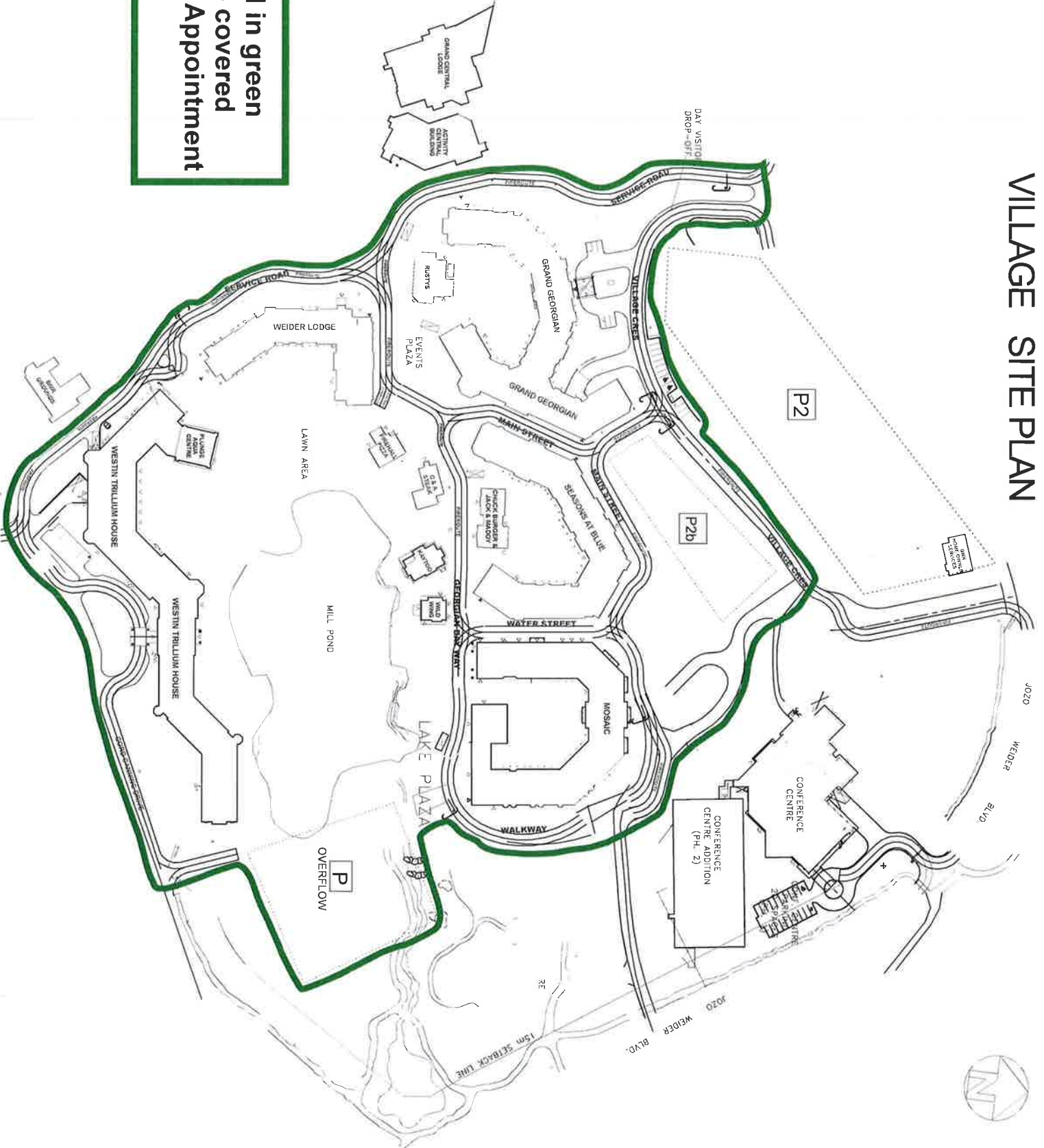
