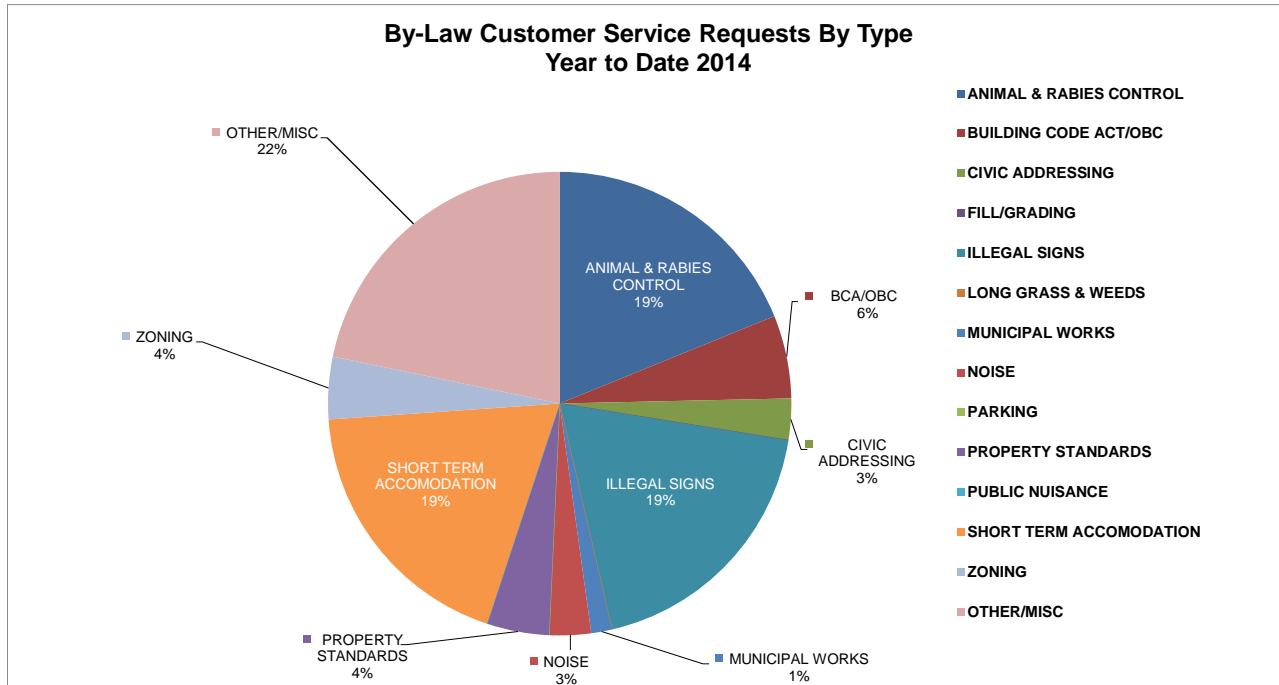

- 1 Year to date 2014 by-law complaints received are **38% lower** than the same period last year: 69 as of Feb 28, 2014 vs. 111 for same period 2013
- 2 46 of the **69** complaints files have been **closed (67.0%)** and 23 (**33.0%**) remain **open** and are still under investigation.
- 3 **The 5 year average from 2010 to 2014 YTD** is 521 complaint files per year.
- 4 **Short Term Accommodation** complaints: **19%** (13) of the total complaints (69) received in 2014 to date.
