A. Recommendations

B. Overview

The Economic Development Advisory Committee (EDAC) is asking Council to approve Steve Simon, the representative from The Blue Mountains Chamber of Commerce, as the new Chair of the Economic Development Advisory Committee. The Georgian Triangle Development Institute has put forward Ken Hale as their representative on the Economic Development Advisory Committee, replacing Andrew Hill, and EDAC is also asking that he be confirmed as a committee member.

C. Background

The former Chair of the Economic Development Advisory Committee (EDAC), Casey Thomson, representing the Thornbury Business Improvement Area, resigned from the Committee two months ago requiring EDAC to vote for a replacement.
