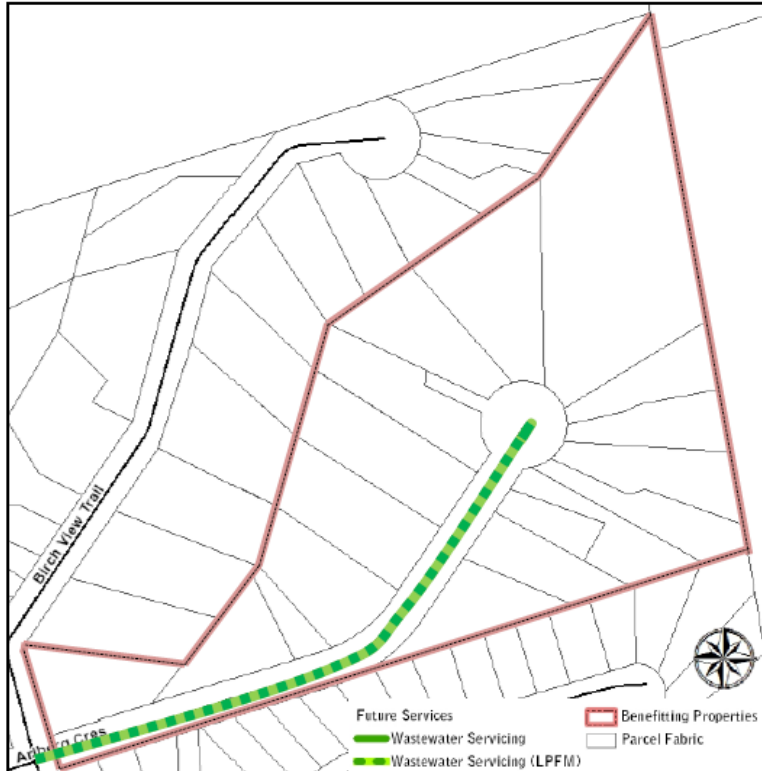
## Proposed Arlberg Crescent Wastewater Capital Charges By-law

### What is being proposed?

Council of The Corporation of the Town of The Blue Mountains will hold a Public Meeting to receive comments on the proposed By-law that will impose capital wastewater charges to benefitting property owners on Arlberg Crescent for the use of the Town's wastewater system and the costs of the new private wastewater system. Should you be unable to attend the Public Meeting, written comments can be submitted to the Clerk in support of, or opposition to, the proposed By-law.

At the April 24, 2017 Committee of the Whole Meeting staff will bring back a report with comments received from the Public Meeting and written responses. Council may consider adoption of the By-law at the May 8, 2017 Council Meeting.

Comments at the Public Meeting aid the Town and Council in their decision making process, so be sure to have your say!

Any person or agency may attend the Public Meeting and/or make verbal or written comments regarding the levying of capital wastewater charges on Arlberg Crescent.
