**A. Recommendations**

**THAT** Council receive Report DOR.14.033 entitled “Authorization of signing an Agreement for the 2014 Centurion Cycling Event”, for information purposes;

**AND THAT** Council authorize the Mayor and Clerk to sign the Agreement with the Blue Mountain Village Association for the 2014 Centurion Cycling Event, provided that such agreement is to the satisfaction of the Town’s Solicitor, Chief Administrative Officer and Director of Community Services.

**B. Background**

This report is providing authorization for the Mayor and Clerk to sign an Agreement with the Blue Mountain Village Association for the 2014 Centurion Cycling Event. This is an annual agreement that has been entered into with the Blue Mountain Village Association since 2011.

The previous 2011 and 2012 Agreements identified that the Town agreed to have the Blue Mountain Village Association and Centurion stage the Centurion Event in and around the Blue Mountains Region and also agreed that the Town would provide a contribution to the cost of the advertising campaign for the Centurion Event and certain in-kind services for the staging of the Centurion Event. It is proposed by staff that the 2014 Agreement would contain the same terms and conditions set out in the previous Agreement and would be at the satisfaction of the Town’s Solicitor, Chief Administrative Officer and Director of Community Services prior to the execution of the Agreement by the Mayor and Clerk..

Town staff has met with the Centurion Cycling logistical planning group for the 2014 event that includes all the participating Municipalities and Counties, Emergency Management Services and representatives from Blue Mountain Resorts, Centurion Cycling and the Blue Mountain Village Association. All required information and certificates have been received and approvals are expected to be received shortly for the event.
