PURPOSE AND EFFECT: The purpose of this consent is to consider a request to sever a 2.687 hectare vacant rural parcel on the eastern portion of the property and deed it as a lot addition to the existing 17.792 hectare rural parcel to the east, containing an existing dwelling, detached garage and roll-off roof observatory. A 10.435 hectare vacant rural parcel would be retained.

This consent is related to Niagara Escarpment Commission Development Control Permit G/R/2008-2009/9128 that was conditionally approved on July 24, 2009.
