**BY-LAW NO. 2008 -**

**DRAFT**

Being a By-law to amend By-law No. 2001-88 with respect to Fire Routes.

WHEREAS pursuant to Section 7.1 (1) (c) of the *Fire Protection and Prevention Act, 1997*, the Council of a municipality may pass by-laws designating private roads as fire routes along which no parking of vehicles shall be permitted and providing for the removal and impounding of any vehicle along any of the fire routes at the expense of the owner of the vehicle;

AND WHEREAS the Council of the Corporation of The Town of The Blue Mountains adopted By-law No. 2001-88 respecting Fire Routes;

AND WHEREAS Council of the Corporation of the Town of The Blue Mountains deems it necessary and expedient to amend By-law No. 2001-88 to establish certain fire routes;

NOW THEREFORE the Council of the Corporation of The Town of The Blue Mountains ENACTS AS FOLLOWS:

1. **Schedule "A" of By-law No. 2001-88 is hereby deleted and replaced with the attached Schedule "A".**

AND FURTHER that this By-law shall come into force and take effect upon the enactment thereof.
