This matter is being referred directly to Council given that the next Finance & Administration Committee meeting is scheduled for November 18th, 2008 and that the related recommendations would not be considered by Council prior to November 14th, 2008 Tree Lighting event.

The Request

The Thornbury BIA will be hosting their first "Tree Lighting" event on November 14th, 2008 from 7:00 pm to 8:00 pm.

The Thornbury BIA will be hosting their annual "Olde Fashioned Christmas" event on December 13th, 2008 from 10:00 am to 10:00 pm

The Noise By-law

Council has on a number of occasions granted relief from the Noise by-law for Special Events such as significant family gathers, "special" birthday celebrations and wedding as well as Community Events such as Olde Fashioned Christmas and The Blue Mountains Library Parking lot Party.

Summary

The proponent is requesting relief from the Noise By-law for specific community events. As noted above, it has been Council's practice to provide an exemption to the Noise By-law for these types of events.

Recommendation(s)

Town Staff are recommending that Council grant exemptions to the Noise By-law for these specific events and that the Thornbury BIA advise neighbouring residents of this event and the potential of noise.
