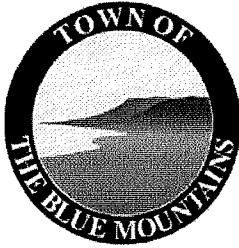

A. Recommendations

THAT this Council receive Staff Report SRB.08.65 and enact the amendment to the Parking By-law attached hereto.

B. Background

1. This report was scheduled for November 25th & December 10th, 2008 Engineering & Public Works Committee meetings but both dates were cancelled.
2. Concern has been expressed by emergency service providers respecting access to the Apple Bowl Parking Area as well as to the private residence and the Bed & Breakfast located to the south of the Blue Mountain Inn.
3. To address this, Town staff are recommending that “both sides – full length” of Ann Heggveit Drive be designated as “No Parking”. In addition, By-law Enforcement and the OPP will proactively enforce the area designated as a Fire Route (extending north from Ann Heggveit Drive).
4. By-law 2003-11 describes Ann Heggveit Drive – Portion So Designated – On the southernmost side along the entire length thereof. The proposed By-law will change this to read – Both sides – full length.

BY-LAW NO. 2008 -

DRAFT

WHEREAS the Municipal Act, 2001, and amendments thereto, enables the council of a local municipality to pass by-laws respecting the placing, standing, stopping or parking of an object or vehicle on highways;

AND WHEREAS Council of the Corporation of the Town of The Blue Mountains has enacted By-law No. 2003-11 and amendments thereto;

AND WHEREAS Council of the Corporation of the Town of The Blue Mountains deems it expedient to pass an amending by-law to By-law No. 2003-11 as amended;

NOW THEREFORE the Council of the Corporation of the Town of The Blue Mountains enacts as follows:

1. Schedule "A" – Ann Heggveit Drive - Portion So Designated is amended by deleting the portion so designated and adding the following:
Both sides – full length.

AND FURTHER that this By-law shall come into force and take effect upon the enactment thereof.
