A. Recommendations

THAT Council receives Staff Report DOR.09.22 "Youth Community Garden" for information purposes.

B. Background

After meeting with the Youth Council on April 7th, 2009 a plan to create an organic community vegetable garden has emerged. An appropriate location would be at Tomahawk Recreation Complex close to a well for convenient watering and in close proximity to where the nursery will be. This particular location currently has no plan for development and is accessible to our community.

The garden will be designed and maintained solely by the Blue Mountains Youth Council and any community member who would like to help. Creating mentorships between experienced gardeners and Youth would help create intergenerational partnerships and activity within our community.

A schedule would be designed for volunteers to follow. There would be approximately 7-10 people responsible for the garden at different times. The size of the garden would be modest to begin with; a measurement of 8mx4m.

A variety of produce from lettuce and herbs to tomatoes and peas would be grown. The plan for harvested crops would be to sell them at local markets and to members of the community. The proceeds would go towards local Youth Council initiatives and back into the garden. If there were specific Youth related events that required snacks it would be ideal to use the vegetables grown from the garden.

This garden would be a means of bringing our community together and would also allow our local youth population to really connect with our environment and be proud of something they developed on their own with support of the Town.

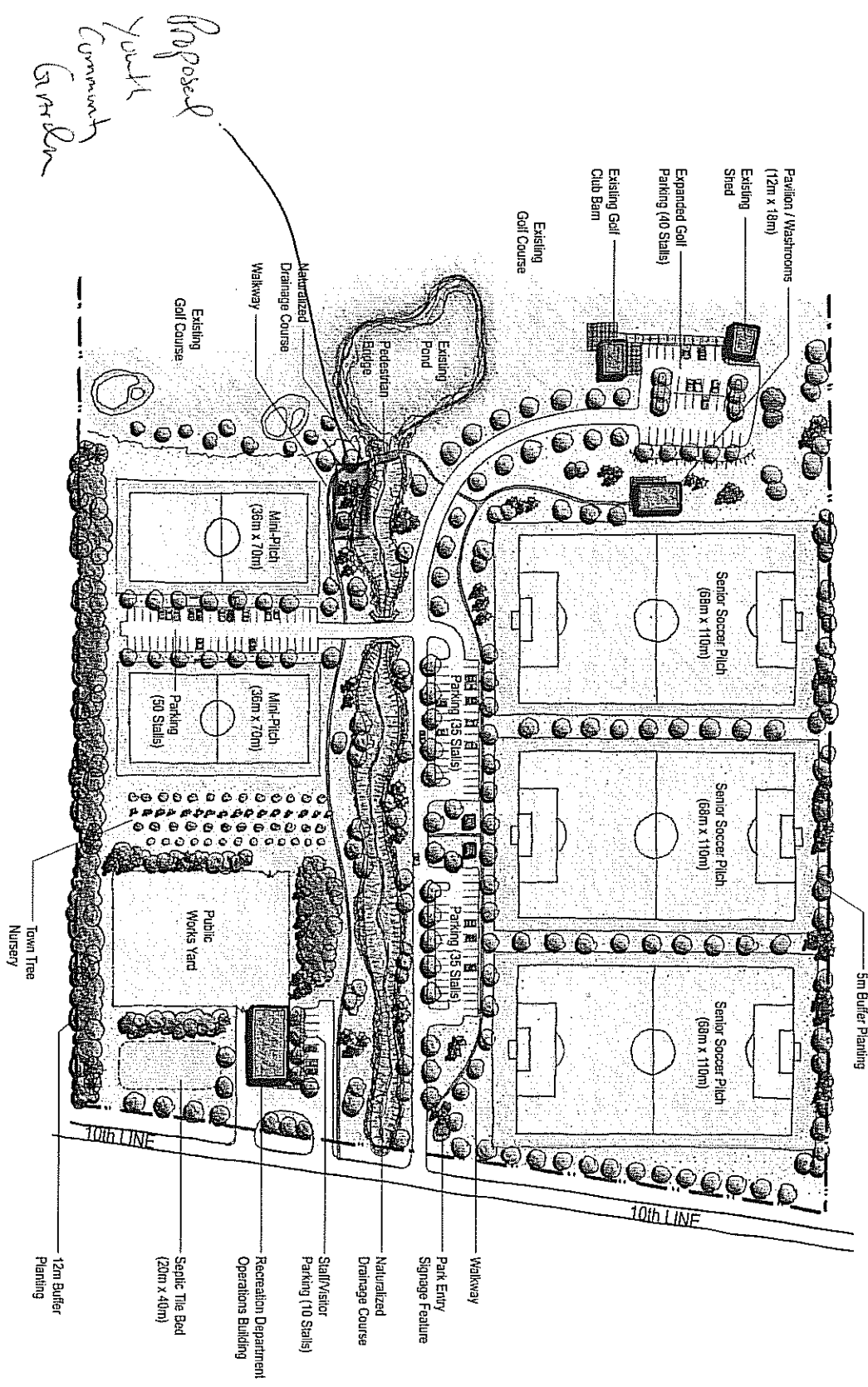
