#### **A. Recommendations**

**THAT Council does receive Planning Staff Report PL.08.92, "Application for Zoning By-law Amendment to remove Holding 'h' Symbol – Keeper's Cove Phase 1, Part Lots 3, Plan 1032 Town of The Blue Mountains";**

**AND THAT Planning Staff supports a Zoning By-law Amendment to remove the Holding 'h' symbol for the remainder of Phase 1 (28 single detached units).**

#### **B. Background**

The purpose of this Zoning By-law Amendment application is to consider a request by the applicant to remove the Holding 'h' symbol from the subject lands in recognition of fulfilling the conditions for the removal. The Holding symbol is proposed to be removed from the remainder of the units in Phase 1 (28 units) that are to be included under a Vacant Land Plan of Condominium. The Holding symbol was previously removed from two units (28 and 29) to permit the construction of Model Homes.

In accordance with Zoning By-law 2006-96, the conditions to the removal of the Holding -h symbol are the Registration of the Plan of Condominium and payment of applicable Development Charges. The proponent has paid the applicable Development Charges under the executed Development Agreement and it is anticipated the Condominium will be registered in advance of the Council meeting to consider the removal of the Holding symbol.

Planning Staff would therefore have no objection to Council granting a Zoning By-law Amendment to remove the Holding 'h' Symbol for the Phase 1 lands.

### **C. The Blue Mountains' Strategic Plan**

The recommendation in this Planning Staff Report is consistent and supports the following Strategic Plans Goals:

Being a By-law to amend Zoning By-law No. 83-40

AND WHEREAS pursuant to the provisions of Section 36 of the Planning Act, the By-law may be amended by Council of the Municipality;

NOW THEREFORE, THE COUNCIL OF THE CORPORATION OF THE TOWN OF THE BLUE MOUNTAINS ENACTS AS FOLLOWS:

1. The Zoning By-law of the Township of Collingwood being By-law No. 83-40, is hereby amended by removing the Holding (-h) symbol from the lands lying and being in the Town of The Blue Mountains comprised of Part Lot 3, Plan 1032, as indicated on the attached key map Schedule 'A-1'.
2. Schedule "A-1" is hereby declared to form part of this By-law.

AND FURTHER that this By-law shall come into force and take effect upon the enactment thereof.
