C. Staff Reports

C.1 Detachment Commander's Report (verbal)

Len Devine advised the Board with respect to Staffing/Absences within The Blue Mountains Police Service.

Len advised that the new Community Policing Chair will be Mr. James Bertram. Mr. Bertram spent 9 years as Deputy Chief of Police for Peel Regional Police and from 2011 to present, is a member of the Georgian College Board of Governors. Their next meeting has not yet been determined.

Detachment Update:

The Blue Mountains Detachment is in good repair and receives constant attention from building manager Ryan Gibbons.

The Blue Mountains officers investigated two incidents that stand out. The first being the robbery at the Mac's Convenience store in Craigleith. The circumstances were a male party entered the store and demanded money. The culprit brandished a kitchen knife. The attendant refused and the culprit fled on foot. Police were called and the OPP canine unit attended. From first request to arrival it took the canine unit 60 minutes to commence their search. The dog tracked the suspect to the old Craigleith train station where the scent was lost. It is suspected the culprit departed this area in a car.

Last week two women fell from the 4th storey roof of the Grand Georgian Hotel. Ambulance, police and security responded to the call. This incident demonstrated that OPP and Resort Security have and maintain a professional relationship. The Resort security assisted police in any way they could without hesitation.

Fraud Education: On the 5th of February Constable Does facilitated a senior's anti-fraud seminar at the Thornbury Library. Conducting the presentation was Brock Godfrey from the Canadian Anti-Fraud Centre.

Constable Does also conducted a crime prevention seminar with the Blue Mountain Village Association. Focus of the forum was crime prevention, counterfeit money and risk assessments.

The Collingwood/Blue Mountains OPP has an ongoing focused patrol where a problem is identified, ideas to correct the problem are brought forth and officers dedicate available time to address the issue. Commencing in mid-February officers will be focusing on thefts of skis and snowboards at the Blue Mountain Ski Resorts.

Martin noted the number of resources tied up for a couple of days at the Grand Georgian but also noted that it was a significant incident.

John Trude advised that the Police had to rule out criminal involvement with respect to this incident.

Martin asked John Trude what the number of hours of the resources that were tied to this incident. John advised that his estimate would be in excess of 120 hours of OPP time. This incident tied up medical staff here as well as in Toronto which is a huge cost to the taxpayer.

Cameron Kennedy asked if the OPP or security appeared before or after the fall. John advised it was after the fall.

Martin lives in the area of The Depot and advised that he was quite impressed with the canvassing of the neighbourhood by the OPP after the Mac's robbery. Martin questioned similar incidents at other communities.

John Trude advised of similar incidents going from Windsor to Ottawa and far north. John confirmed that employees are told to co-operate when this type of situation arises.

Philip Browne advised that through the fraud follow up presentation that victims are often revisited by the culprits.

Len Devine outlined the Statistics for November & December 2015 and January 2016.

Street crimes – a lot of them are from out of town and only here to get rid of their goods. Identify key parties involved.

Len advised they are now capturing all criminal record checks for each check.

John advised that abduction is not something to get too excited about in our area.

John advised that property related crimes and any report such as damage, mischief, graffiti spray painting, broken lights may be a minor call but a call is a call.

Numbers are not showing a trend or danger to anyone in the municipality.

Cameron questioned if assaults are mainly at the village.

John confirmed that most are related to the Village resort area and mostly licensed premises.

December 2015 to March 2016 numbers are high use months for the resort with stats higher in the first quarter of the calendar year. Numbers tend to balance out during the rest of the year.
