### C.1 Detachment Commander's Report (verbal)

Inspector Mary Shannon reviewed the 3<sup>rd</sup> quarter report and provided Board members with the recent 4<sup>th</sup> quarter report, which was reviewed as well. Mary noted that “break and enters” are up 300% from last year at this time . Mary further noted the detachment have retrieved evidence from the crime scenes and are certain the various break and enters are related.

Mary noted that cash was recovered from a locked safe in a hotel room at Blue Mountain Village . After several attempts by the police in contacting guests who rented the room, no one has come forward to claim the money and after 90 days, it is now turned over to the Police Services Board. The money has been placed in a Police Services Board Reserve Fund, with the Town of The Blue Mountains.

Board discussed the need to purchase mobile scales for OPP mobile inspections on Town roadways to ensure vehicles are within their load restrictions, especially with the half load season coming up in the spring. Mayor McKean noted that the Town has set aside \$20,000 in the 2018 budget and if approved on the 12<sup>th</sup> of February, the scales can be purchased right away, if the purchase can hold off until budget approval.

Mary advised that a quote from Massload came in at \$12,529. Mary advised that the purchase can hold off until the budget is passed and requested to have the resolution forwarded to her once adopted, so the detachment can proceed with the purchase.

Mary announced to the Board that Sergeant Len Devine and Administrative Assistant Patty Lowe will both be retiring from The Blue Mountains OPP on May 31. The Board members congratulated both Len and Patty on their upcoming retirement.
