Section 4.05 (3) (d) of the Sign By-law 2001-57 states that:

One (1) fascia sign per business frontage not to exceed a width which is ninety percent (90%) of the business frontage; provided however that the maximum area of the sign shall not exceed an amount which is the lesser of ten percent (10%) of the area of the architectural elevation of the building or 20 square metres.

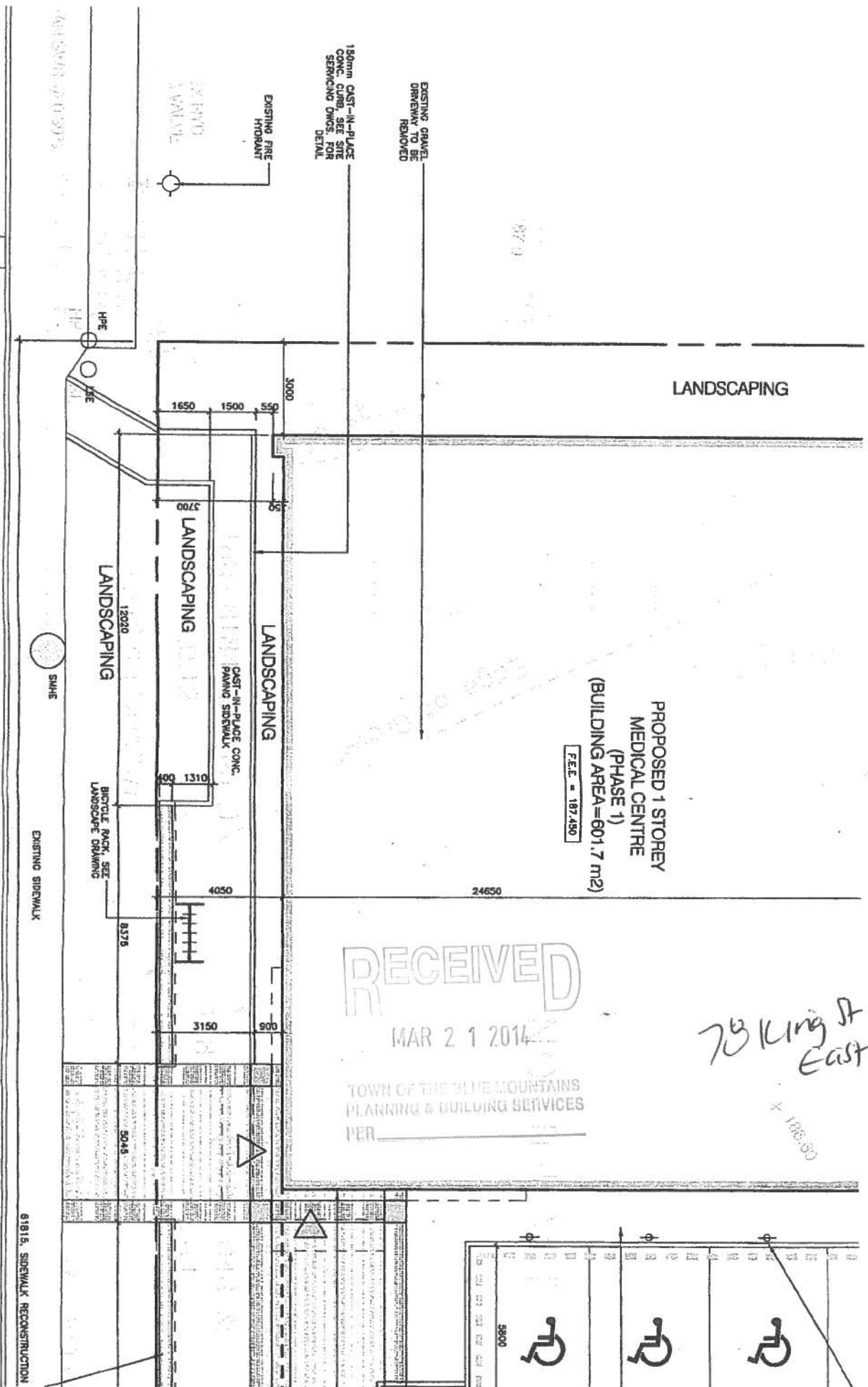
