#### **4. Matters Arising from the Minutes**

##### Municipal Grouping #4 SPC Representative Resignation

The Project Manager advised that correspondence has been sent to the six municipalities included in Municipal Grouping #4, being Chatsworth, West Grey, Southgate, Wellington North, Minto and Hanover, asking them to submit jointly a list of names of possible people to fill this position on the Source Protection Committee (SPC). The Source Protection Management Committee then chooses a name from the list and makes a recommendation to the lead Source Protection Authority, which will in turn appoint the replacement. The deadline to submit a list of names is September 8, 2009 and a recommendation could be expected from the Management Committee at its September 10, 2009 meeting. The new member of the SPC could be in attendance at the September 25, 2009 SPC meeting.

##### Terms of Reference

The Project Manager advised that he has been in discussions with Ministry of the Environment (MOE) officials respecting the amendment to the Proposed Terms of Reference. The Project Manager also advised that the Ministry is considering changing the wording of the section that was inserted into the amended Terms of Reference titled “Implementation of Source Protection Plan Policies”. Following consultation with the Chair, the Project Manager advised the Ministry officials that the wording should be accepted as it was presented.

The Project Manager advised the Ministry officials that if the wording is to be changed, there should be a footnote included in the Terms of Reference specifying that the Minister has made changes to the original submission. A decision is expected in the near future.
