Meeting Notes

March 1, 2011

1. Delegation: Pat Johnson

Pat explained that he has a 100 acre farm on the 10th Line. He has a son going into the apple business and would like to get a severance of land off his farm for him. Has gone to the Planning Dept and told his farm just outside the Specialty Crop designation and minimum farm size is different making it difficult for the severance. Looking into the process of changing the Official Plan designation. He just wanted the Committee to be aware of what he is doing. The Committee has a couple of questions. The Vice Chair thanked Pat for his attendance.

4. Brainstorming Session (Topics of interest for future meetings)

4.1 Need to look into a long term strategy of recreation, increasing tourists/visitors/recreation events now taking place in the agricultural area, impacts. (Jacquie H)

4.2 Should get involved in the Town's Comprehensive review of the Official Plan (J Farmilo). *Peter asked to invite senior planner Cindy Welsh to the next meeting to talk about the consultation process.*

4.3 Should investigate the decline of the apple industry, look for best ideas. Have a workshop (meet to see how we can reverse the decline) Stake holder meeting . Lobby Province. Look into labeling laws. Perhaps there are things the Town can do. (Lance B).

4.4 Concerned about the noxious weed problem such as wild Chervil and Giant Hogweed. What is the County and Town works Dept doing about it and are they preparing for this years season. Do they have a strategy and have the spray now ? (Lynn V)

Does the Town have a response strategy/education program to assist the public with help on private property.

5. **Apple Harvest Festival** Peter McGee looking for a representative to be on the planning committee for the 2011 Apple Harvest festival at Thanksgiving in the Village at Blue Mountains. Al Lockhart volunteered.
6. **Rib Fest** Peter McGee filled the Committee in on a major event being planned this year. It would be a Rib Fest and Rotary Chili cook off the weekend after Canada Day at the Cedar Run Horse Park on Grey Rd 2 and Clark St.
7. **Correspondence** the letters regarding the Canadian Plowing Championship 2011 and the Grey County Farm safety Association were received.
8. **County Official Plan** Peter gave an update. The Province has approved the new Plan with some modifications, not all of which we support. We were looking for a little more flexibility in the rural area designations permitted uses to encourage economic development.
9. **New Member** The Committee passed a motion to add a new member Al Lockhart to the Agricultural Advisory Committee, with Council's acceptance. CARRIED.
