## **11. Correspondence**

- a) Memo from John Cottrill re: Letter from Kathleen Wynne, Premier, re: Control of Invasive Species: Phragmites australis in Ontario; and newspaper article

For a number of years, European Common Reed grass (*Phragmites australis*) has become an increasing problem to area beaches, wetlands and open ditches. There are no natural controls, so many landowners and municipalities have undertaken both chemical and mechanical treatments to try to control the plant. At present, there is no approved herbicide available in Ontario that can be used over or around water.

The Ministry of Natural Resources and Forestry (MNRF) has been active in addressing the challenges in trying to control the plant.

The purpose of this report is to seek your endorsement to send a letter of support to the Premier and MPP's in Ontario to seek their support in approving the use of recognized herbicides for use in aerial applications over wetlands and open water. In addition, a further request is to establish a province wide program, with associated funding, to address the issue in a coordinated fashion on land and in water.

Wayne Brohman advised SVCA will carry out work at the Brucedale Conservation Area and surrounding areas along the Lake Huron Shoreline at a cost of \$100,000. For 5 years, funded by Enbridge.

A draft letter addressed to Premier Kathleen Wynne was reviewed which letter outlines the issue in more detail. All conservation authorities are being asked to support this initiative.

c) Lands Update

1) Boat Lake Agreement - Patterson Camp Cottage Lease

The lease area at Boat Lake is approximately 5 acres in size and contains 5 older cottages, several out buildings, 1 seasonal campsite and 6 non-seasonal campsites.

The "Patterson" portion of the Boat Lake Management Area was purchased by GSC in 1972. The 175 acre parcel of land also contained a cottage lease site that was known as Patterson's Camp. Upon purchase of the land by GSC the Patterson's were granted lifetime access to operate the 5 acre portion of land where the 5 cottages resided. In 1998 the Patterson's relinquished their occupation of the cottage site and GSC took charge of the area. The cottages and accessory buildings were found to be in disrepair and the site was in need of a large scale clean-up. In 1999 staff cleaned up the cottage area site and left only the existing building.

In 2000 the area was offered for public tender to lease the existing cottages with an emphasis of first repairing / refurbishing the existing buildings. The site was eventually leased to Jim and Mariyln Cuming in 2001 for a 5 year period at no cost, pending the cottages were repaired and upgraded. The Cuming's completed all repairs noted by GSC within the first 5 year period. After 2005 the lease was reviewed every 5 years with the current lessee having the first right of refusal pending that the terms of the lease are adhered to. The lease fees are based on a sliding scale with a 4% annual increase and an option to collect taxes should they rise beyond the current rate. The lease rate in 2015 was \$4,212.00.

The Cuming's lease expires on January 31, 2016, and the lessee has stated that they can no longer operate the lease unless the current fees are reduced and the agreement stipulation related to land tax is changed. The Cuming's have requested the following changes:

- Remove the clause making the lessor responsible for the increase in costs due to a new property assessment
- Cap annual lease at \$4,000.00

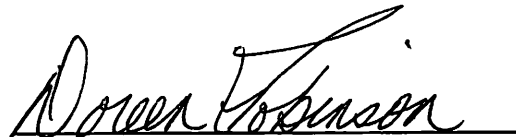
