STAFFING/ABSENCES:

COMMUNITY POLICING COMMITTEE ACTIVITY:

The Community Policing Committee is kicking off a Community Watch program with a pilot project in the Craigeith area. They hope to have the kick off in conjunction with the Grand Opening of the new police office.

DETACHMENT COMMANDERS UPDATE:

The Blue Mountains detachment is complete and there are two officers per platoon reporting for duty at the new location. Grand Opening is scheduled for July 4th rain or shine.

The Blue Mountain Village Association and Blue Mountain Resort continue to work towards providing a Community Policing Office in the Village.

Steve Hardisty continues in the Crime Prevention position (CPTED on business premises as required, Community Education, etc.) and we'll be extending that service into The Blue Mountains. Jim Does will fill that position in September upon Steve's retirement.

PUBLIC INFORMATION/SERVICE.

The DARE program has been completed in BVCS with the final graduation was held on May 14th. Cst Marcey Rivers will continue in her role as the DARE officer for the next three years.

Contact has been made with a local female who is interested in setting up a presentation on recognizing the effects of drug use. She has some adult former drug users who would be willing to speak in a public forum. Arrangements will be made to have a presentation next Fall geared towards adult learning.

OPERATIONS UPDATES:

The Ride for Sight was held in Collingwood this year but the attendance was down due to rainy weather. There were no issues other than damage to Harbourview Park due to the wet weather.

Plans have been made for the Ford Wayne Gretzky Golf Tournament to take place at Lora Bay and The Georgian Bay Club on July 9th to the 12th. We don't anticipate any problems related to the tournament.

Plans are under way for the Wakestock event to be held in Collingwood Aug 7, 8, 9. This will bring approximately 10,000 young people to the area and many will be staying in The Blue Mountains. The Village Association at Blue Mountain is concerned about the large number of youths they expect to attend the bars there.

The application has been submitted for the 2009/2010 RIDE Grant.
