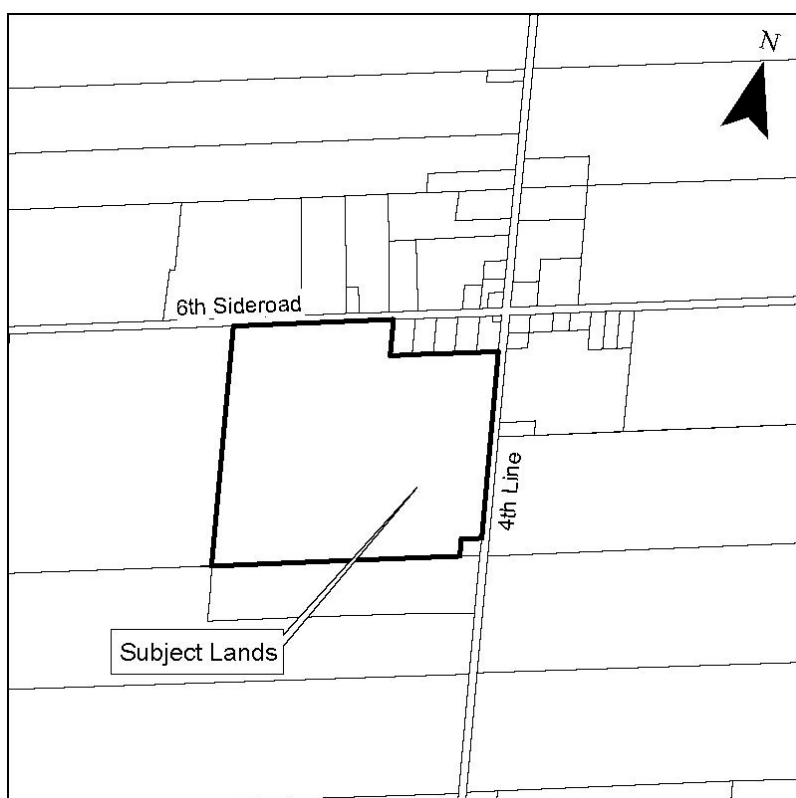
What is being proposed?

The proposal is to add a new permitted use of a black powder blanks shooting range in and around an existing riding ring on a portion of the subject lands, so as to allow for Cowboy mounted shooting. Cowboy mounted shooting is a competitive equestrian sport involving the riding of a horse to negotiate a shooting pattern. Modern events use blank ammunition certified to break a target balloon with twenty feet instead of bullets.

It is noted that this proposed use is also regulated federally through the *Firearms Act*, and the proponent has been consulting with the Chief Firearms Officer accordingly.

A site plan excerpt is on the back of this Notice pertaining to the proposed site location for the black powder blanks shooting range.

The property affected by this application is known legally as Part Lot 6, Concession 5; Part 6, RP 16R-9021; Town of The Blue Mountains.

When will a decision be made?

A decision on this proposal has NOT been made at this point and will NOT be made at the Public Meeting.

After reviewing the application and any comments received, Town staff will bring a recommendation on this project to a future council meeting.

Want to be notified of a decision?

You must make a request in writing if you wish to receive a notice of any decision of Council on this proposal.

Your rights to appeal a decision:

If a person or public body does not make oral submissions at a public meeting or make written submissions to Town of The Blue Mountains before the by-law is passed, the person or public body is not entitled to appeal the decision of Council to the Ontario Municipal Board.

If a person or public body does not make oral submissions at a public meeting, or make written submissions to Town of The Blue Mountains before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.
