E.2 Slabtown Update

Jim McCannell reported that the Town did investigate Slabtown Road to determine the extent of the road repairs, and Staff did do some ditching work and repaired some of the pot holes. Staff will continue to monitor the road and keep up with the repairing the road.

E.3 Private Drainage Outlet

Jim McCannell reported that the owner of a property located east of Grey Road 40 and Highway 26 contacted him about the drainage ditch. Jim McCannell explained to the property owner that this is on private property and therefore it is not the responsibility of the Town to maintain that particular ditch. The property owner indicated that he would like to come to the Committee to discuss this matter further.

Jim McCannell will investigate the property behind Georgian View Estates to determine if additional storm water was being directed to the water course by the Georgian Bay Club.

Staff will provide the property owner with a Town Deputation Form – Request to Make a Deputation to Committee.
