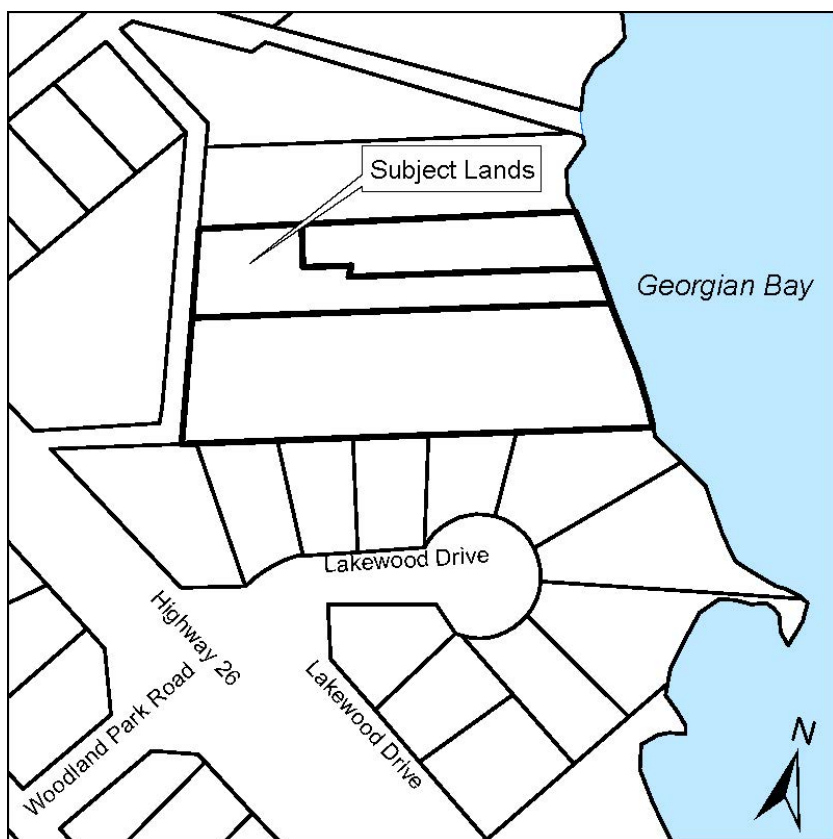

What is being proposed?

The proposal is to address a potential condition of Consent on Application B14-2015 that would reconfigure three residential lots into two residential lots. If the Consent is granted, a Zoning By-law Amendment is required to allow for the proposed new lot fabric to obtain access through the existing registered private right-of-way, rather than a street; and recognizing the natural hazards associated with Nottawasaga Bay, amongst other matters.

This Zoning By-law Amendment application is submitted together with Consent Application B14-2015.

The property affected by this application is known legally as Lots 6 to 8, Plan 377; Parts 1 to 7, RP 16R-6499; Town of The Blue Mountains.

When will a decision be made?

A decision on this proposal has NOT been made at this point and will NOT be made at the Public Meeting.

After reviewing the application and any comments received, Town staff will bring a recommendation on this project to a future council meeting.

Want to be notified of a decision?

You must make a request in writing if you wish to receive a notice of any decision of Council on this proposal.

Your rights to appeal a decision:

If a person or public body does not make oral submissions at a public meeting or make written submissions to Town of The Blue Mountains before the by-law is passed, the person or public body is not entitled to appeal the decision of Council to the Ontario Municipal Board.

If a person or public body does not make oral submissions at a public meeting, or make written submissions to Town of The Blue Mountains before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.

A Note about information you may submit to the Town:

Under the authority of the Municipal Act, 2001 and in accordance with Ontario's Municipal Freedom of Information and Protection of Privacy Act (MFIPPA), all information provided for, or at a Public Meeting, Public Consultation, or other Public Process are considered part of the public record, including resident deputations.
