TAKE NOTICE that the Planning Services Division of the Corporation of the Town of The Blue Mountains has received an application for Site Plan Approval pursuant to Section 41 of the *Planning Act* to permit an Emergency Medical Services Station having an approximate area of 400 square metres and to permit an addition to The Blue Mountains Fire Hall No. 2 (Jerry Teed Fire Hall) having an approximate area of 280 square metres on the subject lands being 796388 Grey Road No. 19.

AND THAT the Planning and Building Committee of Council of the Corporation of the Town of The Blue Mountains will hold a non-statutory **PUBLIC MEETING** at **THE BLUE MOUNTAINS TOWN HALL, 32 MILL STREET, THORNBURY, ONTARIO, COMMENCING AT 7:00 P.M. ON THE 4th DAY OF JULY 2011** for the purpose of receiving comments from the public with respect to the application for Site Plan Approval.

The purpose of this Public Meeting is to receive comments from the public on the request by the applicant to construct an Emergency Medical Services Station and to construct an addition to The Blue Mountains Fire Hall No. 2 (Jerry Teed Fire Hall) located at 796388 Grey Road No. 19.

The subject lands are owned by the Corporation of the Town of The Blue Mountains and are legally described as Pt Lot 2, Plan 1065, Town of The Blue Mountains, and are as shown on the Key Map.

Any person may attend the Public Meeting and/or make written or verbal representation either in support of or in opposition to the proposal.
