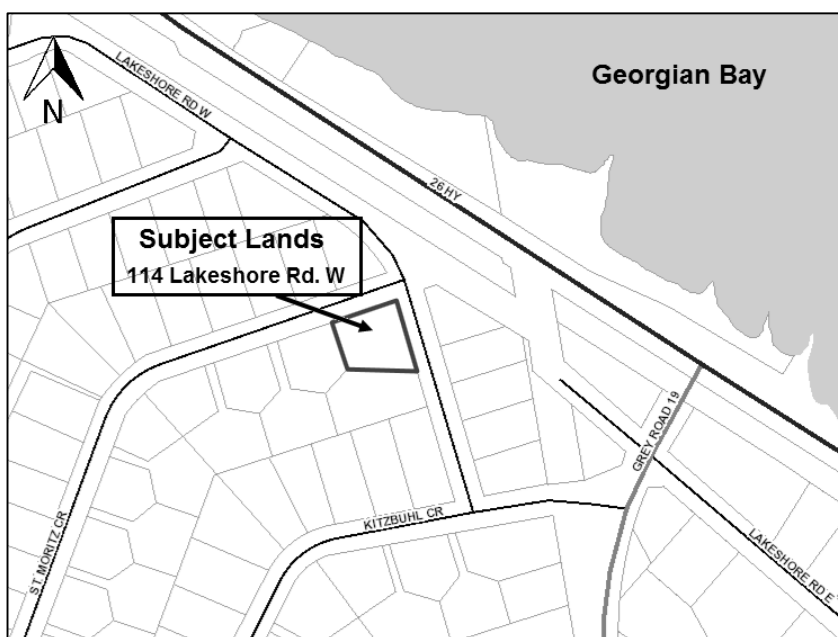
What is being proposed?

The applicant would like to sever the property to create a new building lot.

The proposal is to sever a vacant parcel, approximately 750.5 square metres, with 19.75 metres of frontage on St. Moritz Crescent. The proposed retained parcel would then be 1122.5 square metres, with 24.4 metres of frontage on St. Moritz and contain the existing house and shed. The retained land also has road frontage on Lakeshore Road West. The property is serviced by municipal water and sewer services and fronts on an open and maintained municipal road.

A sketch of the proposal is on the back of this notice.

The legal description for this lot is Plan 822 Lot 37 (formerly the Township of Collingwood), Town of The Blue Mountains.



What happens at a Public Meeting?

The public meeting is your chance to hear more about the proposal and make your views about it known. You may also speak at the meeting or submit written comments. Information from the public will help Council in their decision-making process, so make sure to have your say!

Any person or agency may attend the Public Meeting and/or make verbal or written comments either in support or in opposition to the proposed amendment.

Your rights to appeal a decision:

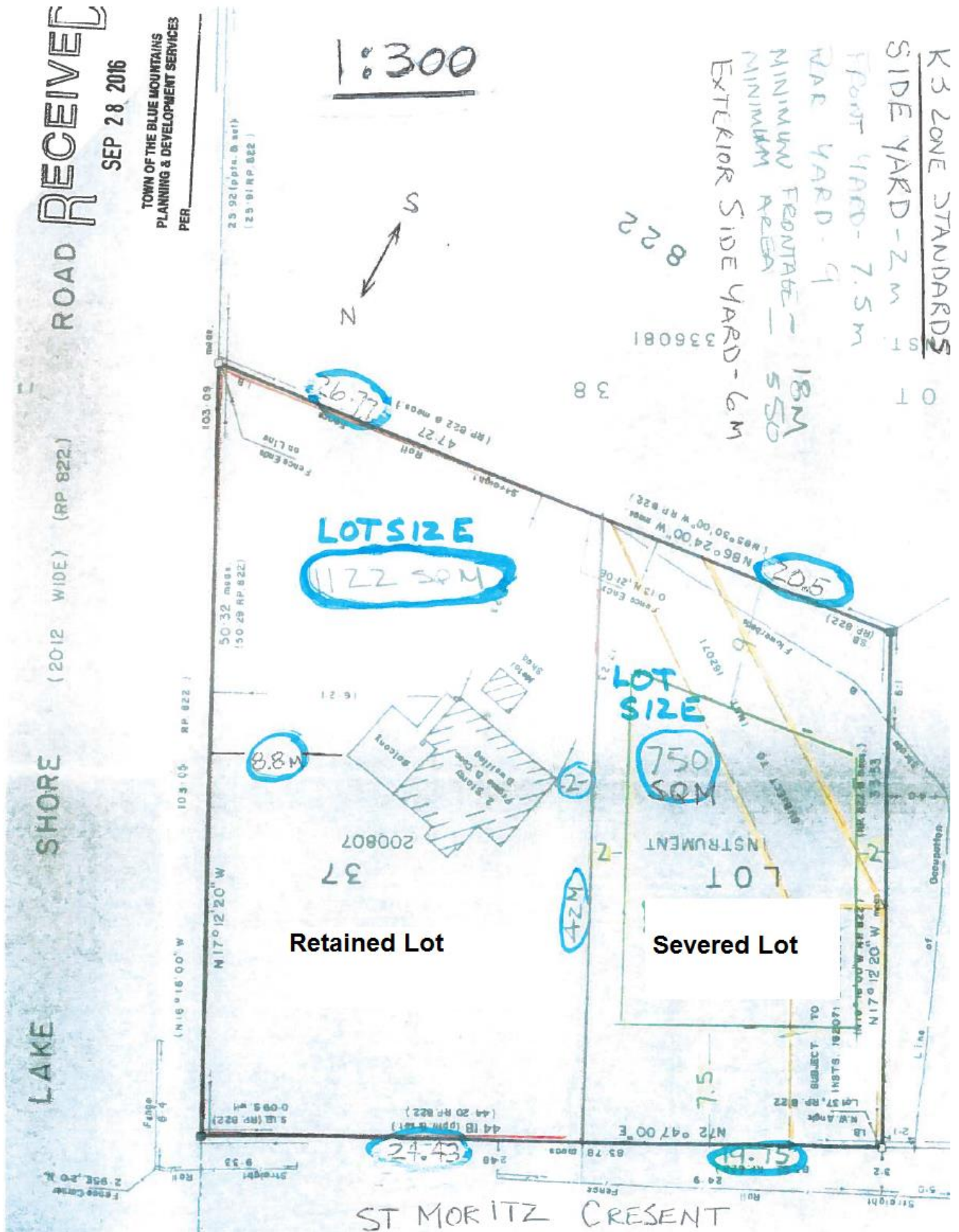
