A. Recommendations

THAT Planning & Building Services Committee receive Staff Report PL.09.67, Street Naming Policy Update, and recommend that Council adopt 'Schedule "A" - Approved Street Name List' attached hereto.

B. Background

On March 02, 2009, Council adopted the Town of The Blue Mountains "Street Naming Policy". At the time of adoption, the Policy did not include proposed street names. The purpose of this Report is to recommend names for the Approved Street Name List for Council's consideration.

As Council will recall, there are various sections to Schedule "A". These are as follows along with the related suggested names:

1. Names Honouring Those Who Have Served Their Country

The first section is related to "Names Honouring Those Who Have Served Their Country". A review of the Cenotaphs revealed the following names:

2. Names Honouring Those who have given Their Life in Public Service

3. Names Honouring Individuals – Local Historical

Some local historical names are also reflected in other categories and are not repeated in this Section (e.g. Parkinson).

“Andrews”

To recognize the owners of the former Andrews Mill located on the Town Hall Site and Thornbury’s first Reeve (1897-1892).

“Olmstead”

First Reeve of Collingwood Township.

4. Names Honouring Individuals – National or International

5. Names Honouring Individuals – Community Service

“Hoffman”

On May 25, 2009, Council adopted a recommendation from the Finance & Administration Committee to include “Community Achievement Awards” recipients on the list of suggested street names. The 2009 recipient was the late Steve Hoffman.

6. Names that reflect the Municipality’s Agricultural and/or Recreational Heritage/Nature

“McIntosh”

Early settlers, David & Hanna Doran (1837) planted a few McIntosh apple seedlings they had brought with them. Their success soon encouraged other settlers throughout the Southern Georgian Bay area to plant apple orchards and it became a year round food staple through the district.

“Russet”

To recognize the contributions made by Kenn and Suyrea Knapman to the restoration and preservation of The Depot and the heritage of Craigleith.
