**PURPOSE AND EFFECT:** The purpose of this consent is to consider a request to sever a 302 square metre rural vacant parcel in the southern portion of the property; and deed it as a lot addition to the existing 35.0 hectare rural parcel to the south, containing an existing dwelling and accessory building. An 86.4 hectare rural parcel would be retained, containing an existing agricultural building, dwelling and two-car detached garage.

This consent is submitted in conjunction with Consent Applications Nos. B05-2015 and B06-2015. The Agent has submitted a planning justification letter in support of these planning applications.
