Thornbury

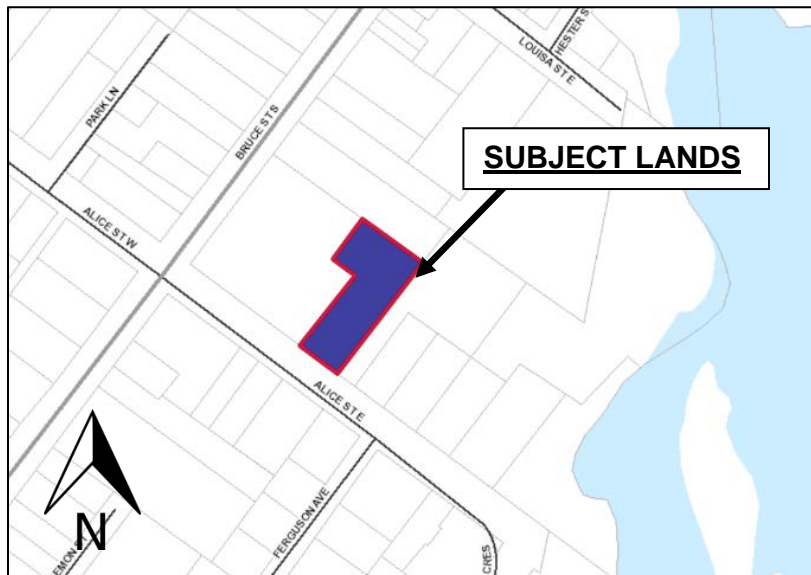

### What is being proposed?

The purpose of this application is to consider a site-specific zoning amendment to permit the conversion of the existing structure into eleven (11) residential apartment dwelling units. The amendment proposes to re-zone the subject lands from the existing R1-1-1 residential zone into an R3 exception residential zone in order to permit an apartment building.

The amendment does not propose to alter the limit of the existing *Hazard* zone boundary currently applied to the property. The lands are also subject to concurrent site plan application P2878.

The legal description of the subject lands is TOWN PLOT PART LOT 4 ALICE E/S.



### What happens at a Public Meeting?

The public meeting is your chance to make your views about it known. Information from the public will help Council in their decision-making process, so make sure to have your say!

To help limit the spread of COVID-19, this Public Meeting will be held in a virtual (online) format. Members of the public are encouraged to provide their comments or questions in writing using email or regular letter mail to the Town Clerk in advance of the Public Meeting. Written comments received in advance will be circulated to Council in advance of the Public Meeting and will be read by the Town Clerk at the Public Meeting.
