In accordance with the Town By-law No. 2006-32, every person who harbours or shelters a dog in the Town for a period in excess of seven (7) days in a calendar year, shall register their dog with the Town on or before March 15th of each year and pay the fee as prescribed.

Dog tags are used in the event that a licenced dog is found at-large. The Town will make every effort to reunite owners with their dog. Licencing fees also support initiatives such as feeding and sheltering of stray dogs, providing emergency medical care for sick or injured stray dogs, immunization control and enforcement, enforcement of the Dog Owner's Liability Act and administration.
