## By-Law Number 2018 -

Being a By-law to amend Zoning By-law No. 83-40 which may be cited as "The Township of Collingwood Zoning By-law"

Whereas the Council of The Corporation of the Town of The Blue Mountains deems it necessary in the public interest to pass a by-law to amend By-law No. 83-40;

And Whereas pursuant to the provisions of Section 34 and 36 of the Planning Act, R.S.O. 1990, c. P.13, the By-law may be amended by Council of the Municipality;

Now Therefore Council of The Corporation of the Town of The Blue Mountains hereby enacts as follows:

- 1. Map 13 to Schedule 'A' to the Zoning By-law of the Township of Collingwood, being By-law 83-40 as amended, is hereby further amended by rezoning the lands lying and being in the Town of The Blue Mountains, comprised of Part Lot 28 Concession 7 from the Residential 'R3-173-h', Residential 'R3-174-h', Residential 'R3-175-h', Residential 'R6-176-h', Public Open Space 'OS1' and Hazard 'H' Zone to the Residential 'R3-h', Public Open Space 'OS1', and Hazard 'H' Zone as shown on the attached Key Map Schedule 'A-1'
- 2. The Holding '-h1' Symbol shall not be removed from the whole or part of these lands until such time as the following is completed:
  - a. Execution of a Subdivision Agreement
  - b. Registration of a Plan of Subdivision
- 3. The Holding '-h2' Symbol shall not be removed from the whole or part of these lands until such time as the following is completed:
  - Confirmation that a road connection is or is not required between Woodland Park Road and the Subject Lands through an approved Addendum Environmental Assessment.
- 4. That Schedule 'A-1' is declared to form part of this By-law.
