

What is being proposed?

The purpose of this application is to consider a Zoning By-law Amendment on a portion of the subject lands known as Tyrolean Hillside that would increase the maximum permitted height from 2 storeys (8.0 metres) to 2.5 storeys (9.5 metres). It should be noted that the Tyrolean Hillside project is a Draft Plan Approved subdivision consisting of 20 lots originally approved in 1998.

The effect of this application is to add a site specific exception to the Residential R1-2 Zone to permit a maximum height of 2.5 storeys (9.5 metres) for single detached dwellings on the subject lands.
