#### B.3.1 Economic Development Strategy Update, February 2020, FAF.20.015

Staff confirmed receipt of 150 business survey responses and 350 resident survey responses. Staff thanked the Economic Development Advisory Committee members for assisting with such strong business survey turnout. It was noted there are three (3) business development workshops scheduled: March 23, 2020 at Blue Mountain Resorts, April 2, 2020 at Marsh Street Centre, and March 26, 2020 at Thornbury Cidery. The workshops are catered towards residents, business owners, and the development community and are being facilitated by Steve Furness of Grey County. Manager of Communications and Economic Development Tim Hendry noted his thanks to the Georgian Triangle Development Institute, and noted its representatives are also assisting with the developer-focused business development workshop.

Andrew Siegwart noted the need to ensure the Economic Development Strategy Sub-Committee plays a part in analyzing the survey data that ultimately frames the workshop conversation.

The Committee discussed whether Craigleith has a present need for a Business Improvement Area, or an overall development plan. Sarah Filion confirmed the Thornbury Business Improvement Area and the Clarksburg Village Association is setting a meeting to discuss synergies and opportunities for collaboration.
