B.1.1 Kathleen Gates and Lisa Dufraimont Re: Parking By-law at Wards Road

Ms. Gates and Ms. Dufraimont spoke regarding the No Parking By-law recently enacted by Council, and the placement of No Parking Signs on Wards Road. Ms. Dufraimont noted that the beach at the end of the Wards Road is valued to them as a community, further noting that her parents have owned property in the area for 33 years.

Ms. Dufraimont noted that the water access at the end of Wards Road has beautiful views, further noting that she has swam and snorkeled in this location for years, as do many other families in the area. Ms. Dufraimont noted that this public beach area provides water access to those that do not own waterfront, further noting though that the No Parking Bylaw now impedes their access to the beach. Ms. Dufraimont noted that Wards Road is a dead end road, and that now they are required to walk or cycle to the public beach, and be in the dangerous position of crossing Highway #26.

Councillor Uram noted that all waterfront access points will be reviewed over the next few months for capacity and normal circumstances, including recreational potential. Councillor Uram noted that the crowds to our beaches are increasing.

Mayor Soever spoke thanking Ms. Gates and Ms. Dufraimont for their deputation, and noted that the by-law may require some tweaking so that it achieves the desired effect to allow local residents to access our beaches. Mayor Soever noted that input is valuable and appreciated.
