

How Will This Affect Me?

Using a water model, the Town of The Blue Mountains recently completed a study of the Town's water distribution system. The study identified areas of concern and deficiencies related to existing conditions and future growth.

The purpose of the Water Distribution System Master Plan is to evaluate Town's long-term water distribution needs and identify a preferred solution to be implemented as required to match the Town's growth.

Public and agency consultation is a key element of the process and input will be sought throughout the study to identify options to address the study findings. Based on this input, alternative strategies will be evaluated to identify opportunities.
