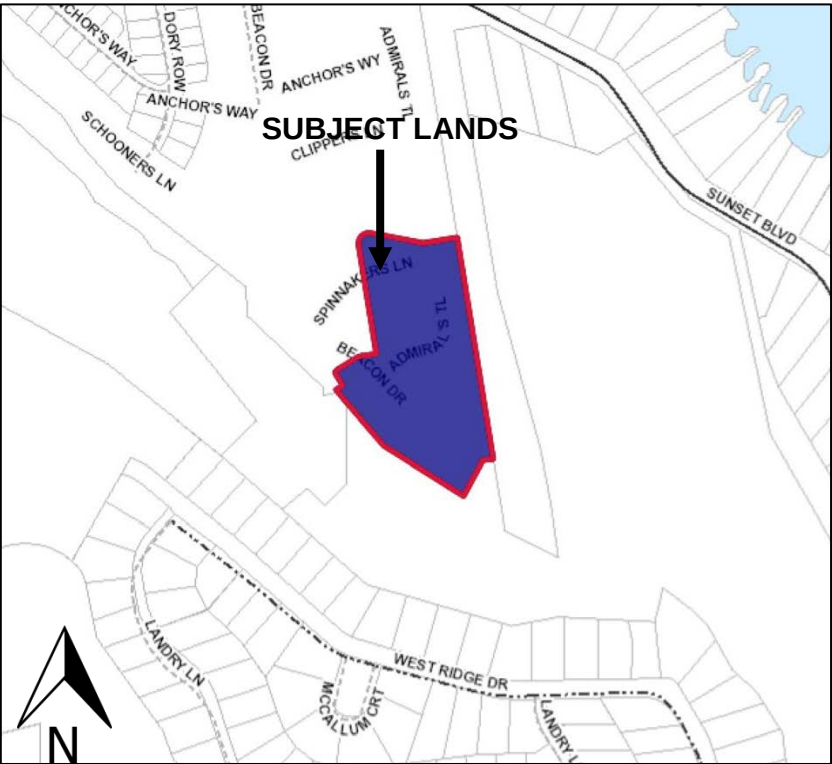

What is being proposed?

The purpose of this application is to consider a lot addition. The effect of the application is to add 152.7sq.m. of land to an abutting parcel. The retained lands are proposed to have a resulting area of 18,340sq.m., while the lands to be added to are proposed to have a resulting area of 67,043.9sq.m.

The severed lands comprise a portion of the Phase 4 lands of Draft Approved Plan of Subdivision 42TCDM-2006-11.

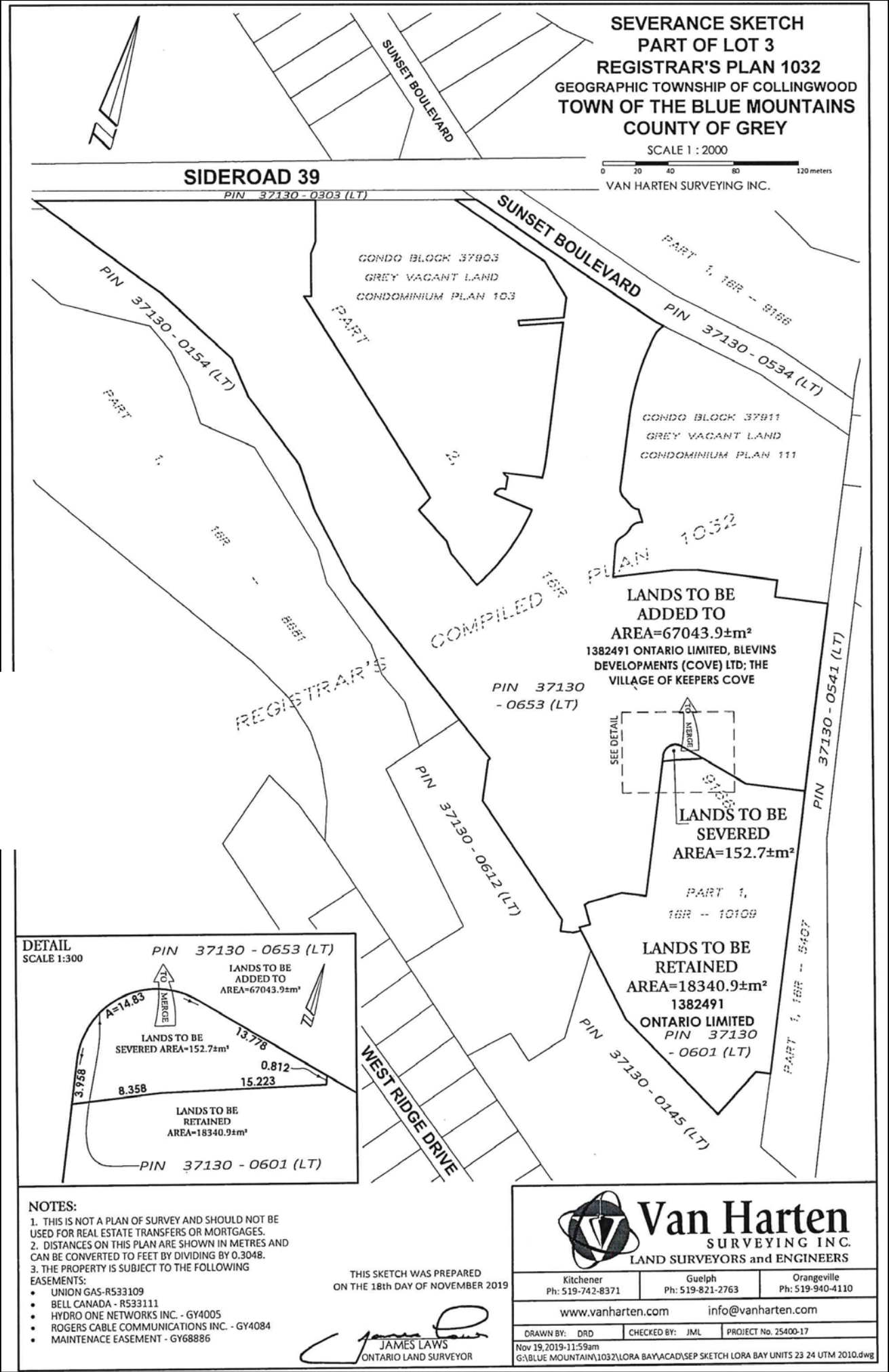
Want to be notified of a decision?

If a person or public body that files an appeal of a decision of the Committee of Adjustment with respect to the proposed consent does not make written submissions to the Town of The Blue Mountains before a decision is made, the Local Planning Appeal Tribunal may dismiss the appeal.
