## By-law Number 2017 – 8

### Being a By-law to Amend By-law 2013-42 Solid Waste Management Fees

**Whereas** Subsections 5(3) and 11 (1) of the Municipal Act enable Council to pass Bylaws respecting matters within the sphere of waste management;

**And Whereas** the Council of The Corporation of the Town of The Blue Mountains has enacted By-law 2013-42 respecting Solid Waste Management Fees;

**And Whereas** the Council of The Corporation of the Town of The Blue Mountains considered amendments to the Solid Waste Management Fees By-law at the January 23, 2017 Public Meeting;

**And Whereas** the Council of The Corporation of the Town of The Blue Mountains deems it expedient to revise Schedule “1”, as attached to the Solid Waste Management Fees By-law 2013-42;

**Now therefore** the Council of The Corporation of the Town of The Blue Mountains hereby enacts as follows:

1. **That** Schedule “1” as attached to By-law 2013-42 is hereby repealed and replaced in its entirety with the attached Schedule “1” to this By-law;

**And Further, that** this By-law shall come into force and take effect upon the enactment thereof.

### Schedule 1

#### Solid Waste Tipping Fees

Item	Description	Fee or Charge
1.	Authorized Waste: Residential, Commercial, Construction and Demolition	\$130.00 per tonne (set fee)
2.	Authorized Waste: Unloaded in the designated area and contaminated with Recyclable Waste, Divertible Waste, Compostable waste or Non-Acceptable waste	Twice the set fee
3.	Recyclable Waste, Divertible Waste, Compostable Waste and or Contaminated Soil: Unloaded in the designated or non-designated area and contaminated with non-conforming material	Twice the set fee
4.	Recyclable Waste: Blue or gray box material, tired, electronic waste, municipal hazardous or special waste, sorted in the designated areas	Free of Charge
5.	Chipped Brush (residential or commercial): Woody plant material less than 76mm (3 inches) in any direction, sorted in the designated areas	Free of Charge
6.	Residential Yard Waste and Brush: Placed in the designated area and free of non-conforming material	Free of Charge
7.	Fruit Processing Waste: Material must be pre-approved by the Town before delivery	Half the set fee
8.	Divertible Waste and Commercial Compostable Waste: Scrap metal, clean wood waste, concrete material, asphalt, Commercial Yard Waste and Brush and un-contaminated soil placed in the designated area and free of non-confirming material	Half the set fee
9.	Contaminated Soil: Owner must provide documentation of certified testing results and obtain Town approval before delivery	\$180.00 per tonne
10.	Asbestos	Not Accepted
11.	Small Quantity Commercial Hazardous or Special Waste: A cost recovery fee may apply	To be determined
12.	Small Quantities of Waste Material: Residential, Commercial, Construction and Demolition	\$6.00 visit minimum fee
13.	Items with Freon: Refrigerators, Freezers, Air Conditioners and Dehumidifiers Certification Fee	\$15.00 each

1.	Sale of Compost	\$0.03 per kilogram <sup>1</sup>
2.	Blue and Gray Recycling Boxes	\$5.00 each <sup>1</sup>
3.	Blue and Gray Recycling Carts (Commercial/Multi Unit)	\$84.00 each <sup>1</sup>
4.	Kitchen Catcher (7 litre)	\$3.00 each <sup>1</sup>
5.	Green Bin (45 litre)	\$10.00 each <sup>1</sup>
6.	Green Cart (Commercial/Multi Unit – 120 litre)	\$50.00 each <sup>1</sup>
7.	Green Cart (Commercial/Multi Unit – 240 litre)	\$60.00 each <sup>1</sup>
8.	Composters	\$30.00 each <sup>1</sup>
9.	Rain Collection Barrels	\$60.00 each <sup>1</sup>
10.	Garbage Bag Tags	\$2.00 each
11.	Garbage Box Tab	\$2.00 each <sup>1</sup>
12.	Illegal Dumping and Littering	\$400.00 per occurrence
