**B.1.1 Stuart Reid, Executive Director, Community Foundation Grey Bruce  
Re: Community Foundation Grey Bruce Information**

Stuart Reid, Executive Director, Community Foundation Grey Bruce provided a presentation to the Committee regarding the Community Foundation Grey Bruce. Mr. Reid provided an overview of the Community Foundation's history, investment information, types of funds managed by Community Foundations, the difference between a community fund and a community foundation, and several programs offered through the Community Foundation. Mr. Reid explained that donations to community groups normally are in the range of \$3,000 but funds are also allocated to agencies. Mr. Reid noted endowed investments see 6.6% annual return typically, and a certain percentage is permitted for distribution to the community. Community Foundations also offer flow in/flow out services where charitable funds are not donated through an endowment fund. Mr. Reid confirmed that any tax receipts are issued by the Community Fund.

Committee member Linda Wykes advised that many groups in The Blue Mountains have been beneficiaries of the Community Foundation Grey Bruce's charitable activities.

Mr. Reid confirmed a 1.5% administration fee is levied by the Community Fund based on the total fund value and the end of the previous fiscal year in addition to a 0.75% fee levied by the investment manager.

Councillor Peter Bordignon thanked Mr. Reid for the presentation.
