A. Recommendations

THAT Council receive Staff Report FAF.20.083, entitled "The Blue Mountains Creator Space Request";

AND THAT Council select Option as identified in the Analysis section of report FAF.20.083.

B. Overview

This staff report outlines options for Council's consideration in relation to The Blue Mountains Creator Space deputation.

C. Background

The Blue Mountains Creator Space made a request to Town staff regarding a request for in-kind facility rentals and to secure a grant from the Canadian Council for the Arts. Staff recommended that the request be presented directly to Council through a deputation. Due to the earlier Council meeting cancellations associated with COVID-19, the May 4, 2020 Council meeting was the first available opportunity to address Council.

In addition, The Blue Mountains Creator Space submitted an application for the in-kind facility rentals through the Town's 2020 Grants and Donations Program.

To better understand the scope of the request, Town staff contacted Tom Strnad, Lead Digital Artist for The Blue Mountains Creator Space for additional details regarding the facility needs. Town staff confirmed the number of days requested per facility which is outlined in the following chart along with the annual subsidized cost.

40 Week Day Rentals – Ravenna Hall	No scheduling concerns (internet is not available at the facility)	\$3,616

Based on the above chart, staff have confirmed that, should Council support the deputation request, rentals at the Craigleith Community Centre, being 20 weekend day rentals and 40 week day rentals, could be accommodated. Staff note that with pre-existing, and recurring rentals at the Beaver Valley Community Centre, it may be more difficult to schedule the facility. However, staff have reviewed the current availability and believe there may be an opportunity to accommodate some Friday bookings for the Small Hall, and some Sunday bookings for the Large Hall. Additional bookings using the Ravenna Hall or the Library Gallery may assist in meeting the needs of The Blue Mountains Creator Space.

In addition, it is important to note that if the request is approved The Blue Mountains Creator Space will be subject to the standard rental contract and requirements including insurance.

Staff have provided options for Council's consideration in the Analysis section of this report.
