John McKean questioned Len if the change could be attributed to the last long weekend in the summer. John asked that these numbers be forwarded to Elizabeth Cornish, Communications & Economic Development Coordinator for the Town for her to post on the town website.

Len confirmed yes it could be and also noted there were no graduations happening in our area in the fall.

Len advised that the STA system in place seems to be working well.

Philip advised there have been meetings with Luc over the summer. They have also had STA meetings with Stu Firth where he was advised that the OPP cannot endorse private security. This led to a discussion with Stu for OPP to approach the Town and Philip advised Stu that the OPP cannot do that. Stu advised there is an area that is problematic with the first one being a lady engaging with interference with neighbours and the STA company. Stu used a camera as a tool which was productive.

Len advised that a Town MLEO did go out with officers to enforce STA's but had no experience in this type of enforcement.

Len advised that the only complaints they are receiving are from members of the public who have rented units and they are not getting their security back from owners. Len advises them this is a civil matter between the owners and themselves.

Martin questioned the alarm by-laws call increase or decrease in the in the past few years.

Cam Kennedy advised there has been a significant decrease in these numbers since the by-law was put in place by the municipality.

John McKean questioned if the noise by-laws pertain to STA's.

Len outlined the numbers from the chart provided.

Philip advised that staff responded to a traffic complaint in Craigleith area and confirmed that it was mostly local people who were doing wrong.

Len advised that the Calls for Service chart is the first time this Committee has received this information.

Mary noted the false alarms & 911 hang ups numbers and confirmed this decrease in numbers makes a significant impact.

Cam questioned if these false alarm & 911 hang up numbers are just in the Blue Mountains.

Mary confirmed they were. Mary noted no concerns in this area.

Philip questioned the fire numbers and questioned if they were event tracked in 2015.

Philip advised that the overall hours are in place for what is noted on the billing model.

John McKean noted the animal control numbers.

Len advised that Brenda Doyle, MLEO for the Town does a good job with handling animal control and that MNR are not concerned with this huge increase in rabid animal numbers.

John advised that MNR have decreased their rabies flights over areas due to costs.

John McKean advised that load restrictions are adhered to in our municipality.

Len advised that Jim McCannell has called him in the past and that the traffic unit was sent out. Len advised that gravel trucks are exempt from this. Len advised that gravel operators protested on the 401 and stopped traffic. The Government gave them a bye until the law was changed. Jim McCannell cannot enforce this and Jim feels it and it is ruining the roads.

John advised this is new information to him.

Len suggested that he set up a meeting with Jim & John to meet with Johnny G to discuss this change.

John advised that if the government has changed the load restrictions, it will be problematic and there will be a lot of road damage done. John advised this comes back to the Asset Management Plan for the municipality. If this has been changed, the Asset Management Plan is no asset and there will be a deficit in this area.

Cam suggested we refer this back to the next meeting. Board is in agreement and are looking into this further.

E. Other Business

E.1 Provincial Offences Court Update

Cam advised that he did not hear anything back from the Attorney General's office with respect to the Provincial Offences Court.

Philip advised that Board with respect to the Traffic Management Plan they are putting in place for the public safety for the officers and advised they are also looking at traffic cameras. Through this process they will be looking into Blue Mountains Resorts and the main traffic in Thornbury. Thornbury and Highway 26 at the Depot would be great areas to maintain cameras for red lights. Philip advised there are some speeding concerns in this area also.

Len advised of the Community Safety Zone in Ravenna.

Martin suggested that he understands the cameras but suggested to facilitate a more convenient court office was the discussion.

Philip suggested discussions or a deputation with the Town of Collingwood.

John agrees with looking into use of the POA court and sharing of staff etc. and feels we need to look at the service aspect.

Cam asked if the town looking to spend money to look into this.

John feels this makes sense from a time savings point of view with respect to the Officer. John thinks Council would look at this. John feels this would be an enhancement of services and suggested we could have an officer dedicated to STA.

Philip advised that he supports the by-laws and agrees with staff working with by-law officers. Philip advised there is a significant cost getting an officer who can be a traffic officer and to work with by-laws on traffic. Philip confirmed there would immediately be a savings by going straight time versus overtime so they can attend court in Owen Sound. Philip suggested we give this to Len to pull this data together and design a plan.

Mary advised that the building already exists and is currently running as a POA court.

Philip advised that Caledon is available to come up to visit the site visit.

Martin advised that proof of the concept is already there and suggests there is more than enough to ensue or endorse from it.

Mary advised that it is the Attorney General Office who would need to support this.

Mary advised that the people who chose the trial option on their tickets are looking for deals.

Philip suggested there is a good opportunity for this proposal right now as Collingwood currently uses 1 day per month. Philip feels we have the ability to schedule and capitalize on savings on our overall costs.

Cam will try again to contact the ex-attorney general for suggestions to move this process along.

E.2 BVCS Cross Walk in front of Library

Cam advised that been advised about vehicles passing and blocking the intersection in this location. Drivers are paying no attention to the crossing guards.

Len advised that he will talk to the Officers to patrol this area more frequently.

E.3 Cam thanked Philip for his service to the Blue Mountains Police Services Board. The Board wished Philip well in his new position in Huronia West.
