C. Matters for Discussion

C.1 Highway 26 Update – Mayor Alar Soever

- Premier of Ontario, at the Mayor's request, temporarily lowered the speed limit on Highway 26 near Northwinds to 50 km/h until October 13, 2020, which has been received well by some, and not received well by others
- Rationale for temporary speed reduction: rate of speed and dangerous passing near Northwinds Beach, and high number of pedestrians
- Ontario Provincial Police are providing feedback to staff on the speed change
- Noted the speed limit is set by Ministry of Transportation, but the fluctuation in speeds between Collingwood and Craigleith requires further review and a longer-term solution
- The speed reduction may cause an increase to vehicular traffic on secondary routes to enable vehicles to avoid the area of reduced speed
- Comments to be relayed to Ministry of Transportation including: potential installation of signage to warn motorists of the reduction in speed from 80 km/h to 50 km/h
- Mayor Soever noted before a permanent solution is determined regarding speed limit in the Craigleith area, an evaluation of options available will be considered

C.2 Lobster Fest Event Update – Councillor Rob Sampson

- Event scheduled for July 25, 2020
- 525 meals sold, with tickets cut off July 21, 2020
- Proceeds from the event split between Grants and Donations Committee, Marsh Street Centre, Beaver Valley Outreach, and the Legion
- Event reviewed and approved by the Public Health Unit
- Councillor Sampson noted his thanks to Town staff who have assisted in pulling event details together

C.3 BMVA/TBM Ambassador Program – Chief Administrative Officer Shawn Everitt

- Chief Administrative Officer Shawn Everitt noted his thanks to Andrew Siegwart and Patti Kendall of the Blue Mountain Village Association for allowing the Town to jointly use the Ambassador program
- Noted there has been difficulty in recruiting interested individuals for the Ambassador program, but outreach has also been made to the local service clubs to confirm if there are interested individuals

C.4 Updates from Task Force Advisory Participants

Reverend Dr. Grayhame Bowcott

- 10 recipients of the Seniors Meal Program have dropped off the list, a program assessment will be conducted by the chef overseeing the program
- Villages Meal Program in conjunction with Beaver Valley Outreach has seen consistent, steady numbers, which may result in the program continuing into the school months
- Adequate number of volunteers at this time

Carolyn Letourneau

- Daycare and Day Camps running at reduced capacity
- Virtual store being developed
- Treasure Shop will launch a soft opening soon
- Emergency services continue to be offered
- Community Garden is thriving

Tim Newton

- Digital Main Street Program continues
 - Any business operating within 1km of a downtown core is eligible to apply for \$2,500 grant for digital transformation
 - Digital Service Squad services continue

Steve Simon

- Local realtors are very busy as interest in the area increases
- May see a shift to more seasonal residents staying full time, or a majority of the time
- Bluewater District School Board will provide Town staff with their school aged children projections, as there are a number of families from the Greater Toronto Area moving into the area

Derek Hammond left the meeting at 9:30 a.m.

 Steve noted his prediction that a number of residents who typically go south for the winter will not be doing so over the 2020/2021 winter season

- May result in ski rental shortages where homes were previously rented out are now being occupied year-round by the owner
- Noted a survey is needed to understand how the local demographic is changing –
 the Leisure Activities Plan survey (being released shortly) does include questions
 related to the intentionality of residents which will be valuable information
 moving forward this could also include looking to Grey County and partnering
 with Blue Mountain Village to gather additional meaningful information

D.1 Julie Green, Wendy Papernick, and Nancy Phillips Re: Recent Problems at Council Beach

- Homeowners group in the Council Beach area have been pleased with the
 measures staff have implemented in response to concerns including: 6 additional
 By-law Officers for proactive enforcement, parking signs installed, and additional
 parks staff and weekend shifts for garbage collection
- Noted that with the presence of by-law staff and enhanced parking control measures, the beaches do not appear to be overcrowded, and users are enjoying the space responsibly
- Andrew Siegwart noted Blue Mountain Village's visitors are well-informed on safety protocol and this is in part due to the assistance of security staff, ambassadors, and parking management staff
- Andrew further noted the Village has structured its programming to cater to overnight guests, and as such, is seeing more overnight guests than day visitors
