

# What is being proposed?

The Blue Mountains Council will be holding a Public Meeting to provide information to the public and to allow the public the opportunity to review and comment on the 2021 Draft Budget and supporting Tax Rate Changes as well as the 2021 Draft Water and Wastewater Budget.

Notice is hereby given that the Council of The Corporation of the Town of The Blue Mountains, at its regularly scheduled Council meeting on Monday, February 8, 2021, intends to adopt the Estimated Revenues and Expenditures for all departments of the Town for the year 2021 and intends to adopt the 2021 Water and Wastewater Budget.

Copies of the 2021 Draft Budget and the 2021 Draft Water and Wastewater Budget will be available through the Town's website, <a href="https://www.thebluemountains.ca">www.thebluemountains.ca</a>.

Please note that in prior years, The Blue Mountains Council would also hold a Public Information Centre in advance of the Public Meeting. Due to the COVID-19 pandemic, a Public Information Centre will not be held.

### **Virtual Public Meeting Information**

To help limit the spread of COVID-19, this Public Meeting will be held in a virtual (online) format. You are encouraged to provide your comments or questions in writing using email or regular letter mail to the Town Clerk in advance of the Public Meeting. Written comments will be circulated to Council. Comments received at least one (1) day in advance of the Public Meeting (by January 8, 2021 by 10:00 a.m.) will be read by the Town Clerk at the Public Meeting.

Anyone wishing to speak on this matter at the Public Meeting is encouraged to preregister early, and no later than five (5) days in advance of the Meeting (by <u>January 4</u>, <u>2021</u> at 10:00 a.m.). For those without a computer, a dial-in number is available.
