RE: Water Pressure Zone 4C Distribution Improvements Notification of Project #2

Dear Resident,

This letter is to advise you of upcoming Engineering & Construction work to improve the water distribution system in the area of your property. The Town has awarded the contract for the completion of the detailed engineering design and construction contract administration to WT Infrastructure Solutions Inc. (WT). WT and their sub-consultants will be on-site intermittently starting November 23, 2020 over the next several weeks to drill boreholes within the road right-of-way for the geotechnical investigation followed by surveying and utility locates to confirm existing conditions. This work will be completed during normal business hours and there will be no need for the sub-consultants to enter your property for this project other than to confirm the location of your property line.

The project is being undertaken to improve water pressure consistency and fire flow capacity in the area within and surrounding Pressure Zone 4C. Pressure Zone 4C is made up of the area locally know as Tyrolean Village and includes Craigmore Crescent, Arlberg Crescent, Birch View Trail, Tyrolean Lane and Kandahar Lane. The project was initiated last year and was delayed due to the Provincial Orders related to Covid 19. It is now moving forward with an expanded scope which includes the replacement of existing watermain.

The design will be completed this spring with construction starting this summer. Additional information will be provided in advance of the construction work being started. This project will include construction in the areas of Craigmore Crescent between County Road 19 and Settlers Way, Tyrolean Lane between Craigmore Crescent and Arlberg Crescent and Birch View Trail between Arlberg Crescent and Brooker Boulevard. 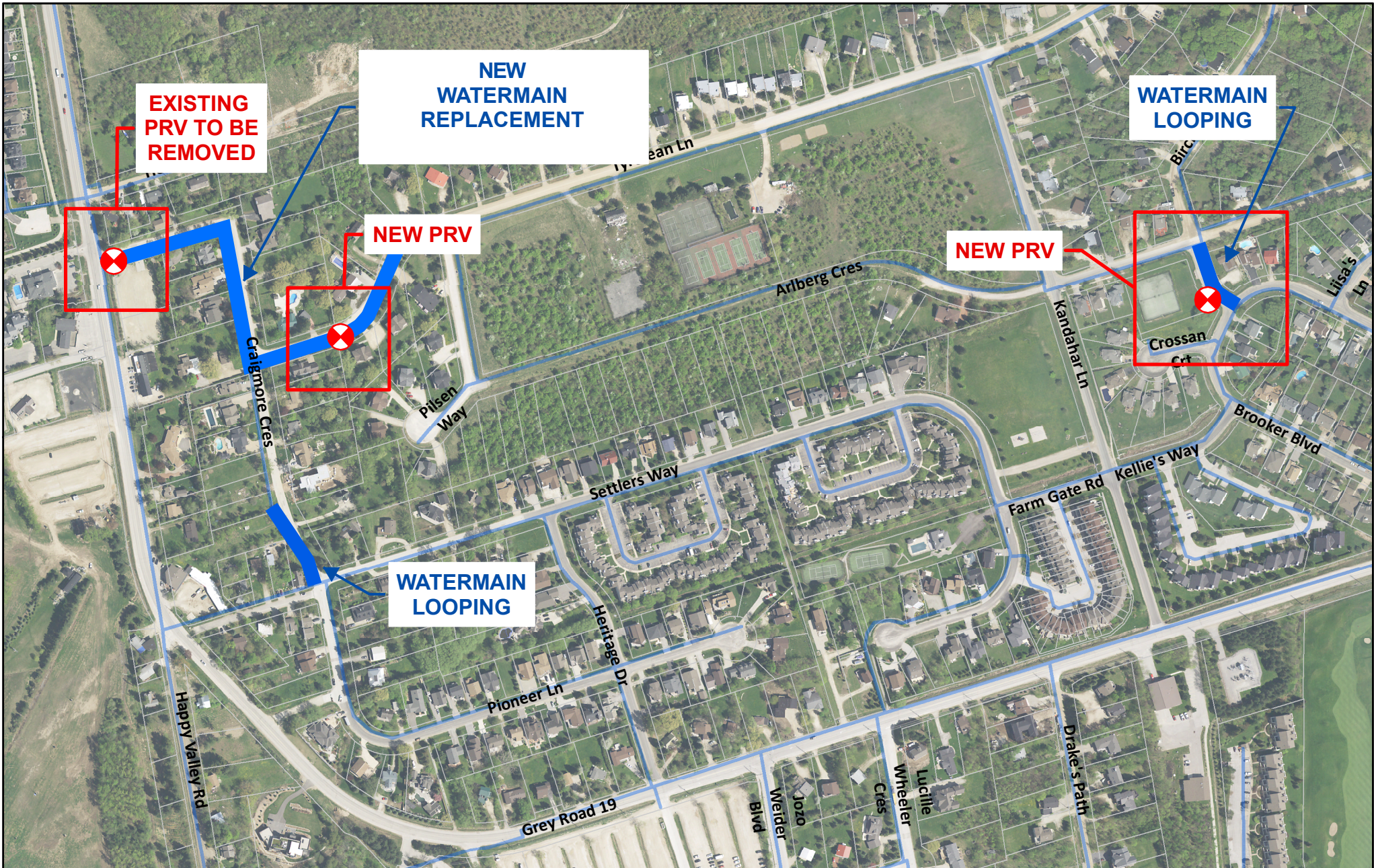

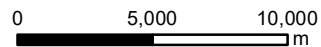
