TO: 2022 Municipal Election Candidates

RE: Certificate of Maximum Amounts for the 2022 Municipal Election

In accordance with the *Municipal Elections Act*, section 88.20(13), on or before September 26, 2022, the Clerk shall provide each candidate with:

- 1. Final Certificate of Maximum Campaign Expense Limits
- 2. Final Certificate of the Amount Permitted to be Spent After the Close of Voting for Parties, etc.
- 3. Final Certificate of Maximum Contributions to Own Election Campaign

The number of electors to be used in the final calculation is the greater of the number of electors for the office from the Voters List as it existed on Nomination Day of the previous election, including changes made on that day, OR the number of electors on September 15 in the current election, including changes made on that day.

1. Final Certificate of Maximum Campaign Spending Limits

Office of Mayor - \$7,500.00 plus \$0.85 per elector (13,751 electors on September 15, 2022) = \$19,188.35

Other Offices - \$5,000.00 plus \$0.85 per elector (13,751 electors on September 15, 2022) = \$16,688.35

2. Final Certificate of the Amount Permitted to be Spent After the Close of Voting for Parties, etc.

Office of Mayor – 10% of the amount calculated above (\$19,188.35 X 10%) = \$1,918.84

Other Offices – 10% of the amount calculated above $($16,688.35 \times 10\%) = $1,668.84$

3. Final Certificate of Maximum Contributions to Own Election Campaign

Office of Mayor - \$7,500.00 plus \$0.20 per elector (13,751 electors on September 15, 2022) = \$10,250.20

Other Offices - \$5,000.00 plus \$0.20 per elector (13,751 electors on September 15, 2022) = \$7,750.20




