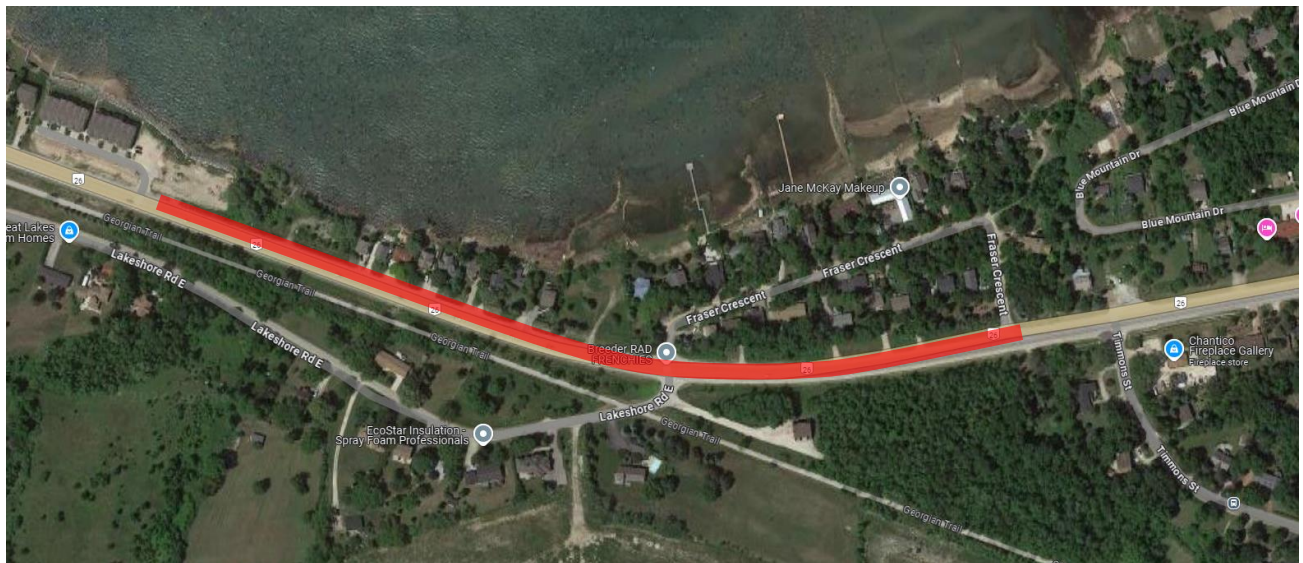

The work includes temporary erosion and sediment control, earth excavation and grading, placement of road granular, and hot mix asphalt within the limits of construction from August 12, 2024, until November 15, 2024.

On behalf of the Owner, Eden Oak (Trailhead) Inc., we would like to inform all residents and property owners that sedimentation/erosion control measures, earthworks, and road improvements will be starting on Highway 26.

Works are expected to commence the week of August 12, 2024, or shortly thereafter, and to continue through till November 15, 2024. Majority of the construction work will take place in accordance with the Town Noise Control Bylaw 2002-9, however there may be some construction outside the specified hours to minimise traffic disruption and/or enhance worker safety.

The contractor will install traffic signages to delineate the construction area. While work is ongoing, residents may experience traffic congestion and some delays when accessing their driveway. Please ensure to take extra caution when construction vehicles and workers are present. Traffic control personnel and signages will be on site and should be followed.
