By-Law Number 2019 – 64

Being a By-law to appoint a Fire Chief

Whereas section 6(1) of the Fire Protection and Prevention Act, S.O. 1997 c. 4, as amended, authorizes municipal councils to appoint a Fire Chief; and

And Whereas Council of the Town of The Blue Mountains deems it appropriate to appoint a Fire Chief for the Town of The Blue Mountains Fire Department;

Now Therefore Council of The Corporation of the Town of The Blue Mountains hereby enacts as follows:


1. That Stephen Conn is hereby appointed as Fire Chief for the Town of The Blue Mountains. In accordance with the approved Terms of employment, effective December 17, 2019.
2. That By-Law No. 2019 – 38 is hereby rescinded and repealed.

And Further that this By-law shall come into force and take effect upon the enactment thereof.

Being a By-law to Appoint an Interim Fire Chief for the Town of The Blue Mountains

Whereas section 6(1) of the Fire Protection and Prevention Act, S.O.1997 c.4, as amended, authorizes municipal councils to appoint a Fire Chief;

And Whereas the Fire Chief position for the Town of The Blue Mountains (the "Town") is vacant within the Town of The Blue Mountains, effective August 9, 2019;


And Whereas Town By-Law No. 2016-76 appoints Steve Conn to the position of Deputy Fire Chief for the Town of The Blue Mountains;

And Whereas By-Law No. 2012-65, being a bylaw to establish and regulate the Town's Fire Department defines the position of "Deputy Chief Fire" as the "one person appointed by Council to act in the place of the Fire Chief in his/her absence, incapacity, or in the case of a vacancy in the department and shall be designated Assistant to the Fire Marshal", and as such Deputy Fire Chief Steve Conn will assume the role of Interim Fire Chief and have all powers of the duties of the Fire Chief, effective August 9, 2019;


Now therefore the Council of the Town of The Blue Mountains enacts as follows:

1. That effective August 9, 2019, Steve Conn is appointed to the position of Interim Fire Chief for the Town of The Blue Mountains, with all the powers and duties of the Fire Chief until otherwise directed by Council.
2. That effective August 9, 2019, By-Law No. 2014-84 is repealed.

Being a By-law to appoint a Fire Chief



WHEREAS Subsection 210 (31) of the Municipal Act, chapter M.45, R.S.O. 1990 and amendments thereto enables Council of a local municipality to pass by-laws for the establishment and operation of fire-fighting services;

AND WHEREAS Council deems it expedient to appoint a person to the position of Fire Chief for the Town;


NOW THEREFORE Council of the Corporation of the Town of The Blue Mountains hereby enacts as follows:

1. THAT Ronald Doherty is hereby appointed to the position of Fire Chief for the Town of The Blue Mountains as per the approved terms of employment.
2. THAT By-laws No. 83-12 of the former Corporation of the Township of Collingwood and No. 96-27 of the former Corporation of the Town of Thornbury are hereby rescinded and repealed.
